ORDINANCE 14-013

AN ORDINANCE AMENDING THE CODE OF ORDINANCES, CHAPTER 90 - FEES, ARTICLE V. RECREATION USER FEES, DIVISION 1 – SANIBEL RECREATION CENTER, SECTION 90-501 – RECREATION USER FEES; AMENDING THE CIVIC CENTER AEROBICS ROOM PER CLASS FEE (WITH CENTER 4 LIFE MEMBERSHIP); PROVIDING FOR CODIFICATION AND SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Sanibel City Council has established the Sanibel Recreation Center Recreation User Fees; and

WHEREAS, the Civic Center aerobics room class fee with Center 4 Life membership was inadvertently listed at \$4.00 rather than \$3.75 per class; and

WHEREAS, the City Council finds it necessary and appropriate to amend the fee as set forth herein;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Sanibel, Florida, that:

SECTION 1. Chapter 90 – Fees, Article V. Recreation User Fees, Division 1 – Sanibel Recreation Center, Section 90-501 – Recreation User Fees, be amended as set forth in the attached Recreation Programs and Fee Schedule, incorporated herein and attached as Exhibit “A”, with underlining indicating additions and strike-through indicating deletions.

SECTION 2. CODIFICATION.

This ordinance shall be deemed an amendment to the Code of Ordinances of the City of Sanibel and the Sanibel Code of Ordinances is hereby amended.


SECTION 3. SEVERABILITY.

SECTION 4. Effective date.

This Ordinance shall be effective immediately upon adoption.


