

- 1 but prior to initiation of prosecution in county court, except as provided in subsection
2 (d) herein. Failure to pay such fines or any other violation of the parking regulations
3 shall be punishable as provided by law.
- 4 (b) Any unattended vehicle creating a traffic hazard or found in a restricted parking zone
5 as set forth in section 21-34.2 may, in addition to the fines provided herein, be removed
6 and the expense of said removal be charged to the owner of the vehicle.
- 7 (c) Violations of parking regulations in designated handicapped parking spaces shall be
8 punishable by the maximum fine as allowed by state law.
- 9 (d) Violations of parking regulations on public or private property in a space which has
10 been designated as a fire zone or fire lane shall be punishable by a fine of ~~fifteen dollars~~
11 ~~(\$15.00)~~ an amount established by Resolution approved by the City Commission if
12 paid within ten (10) calendar days, and of a higher amount established by Resolution
13 approved by the City Commission ~~thirty dollars (\$30.00)~~ if paid after ten (10) days
14 but prior to initiation of prosecution in county court. Failure to pay such fine or any
15 other violation of the parking regulations shall be punishable as provided by law.

17 **SECTION 3.** If any clause, section or other part of this Ordinance shall be held by
18 any Court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional
19 or invalid part shall be considered as eliminated and in no way affecting the validity of the
20 other provisions of this Ordinance.

22 **SECTION 4.** All Ordinances or parts of Ordinances in conflict herewith are hereby
23 repealed to the extent of such conflicts.

25 **SECTION 5.** It is the intention of the City Commission of the City of Oakland
26 Park, that the provisions of this Ordinance shall become and be made a part of the Code of
27 Ordinances of the City of Oakland Park, Florida, and the Sections of this ordinance may be
28 renumbered, re-lettered and the word "Ordinance" may be changed to "Section," "Article,"
29 or such other word or phrase in order to accomplish such intention.

30

31 **SECTION 6.** This Ordinance shall be effective upon its passage and adoption by
32 the City Commission of the City of Oakland Park.
