## **ORDINANCE 16-04**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF EL CENTRO REPEALING AND READOPTING SECTION 17-57, DIVISION 1 OF ARTICLE III OF CHAPTER 17 OF THE CODE OF EL CENTRO RELATING TO SPEED ON CERTAIN **STREETS** 

THE CITY COUNCIL OF THE CITY OF EL CENTRO, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS:

- SECTION 1. Section 17-57, Division 1 of Article III of Chapter 17 of the El Centro City Code is hereby repealed.
- SECTION 2. Section 17-57, Division 1 of Article III of Chapter 17 of the El Centro hereby readopted to read as follows:
- "Sec. 17-57. Same – Certain Streets.
  - (a) Pursuant to Section 22358 of the Vehicle Code of the State and upon the basis of an engineering and traffic investigation, the speed permitted by state law outside of business and residence districts as applicable upon the following streets is found to be greater than is reasonable or safe under the conditions found to exist upon such streets, and it is hereby declared that the prima facie speed limit shall be as herein set forth on those streets or parts of streets herein designated when signs are erected giving notice thereof:

(b) The Council may, by resolution, establish lesser speeds than established herein in areas adjacent to schools."

SECTION 3. This Ordinance shall take effect thirty (30) days from and after its adoption. Within fifteen (15) days after adoption, it shall be published once in a newspaper, published and circulated within the City of El Centro, California.
