11	WHEREAS, in the 2019 Regular Session, the Florida legislature enacted a new statue
12	prohibiting local governments from requiring permits or fees for pruning, trimming or removing
13	of trees on residential property if the property owner obtains specified documentation; and
14	
15	WHEREAS, the City of Maitland Code of Ordinances regulates and protects the tree
16	canopy within the City of Maitland in Chapter 8 of the Code of Ordinances; and
17	
18	WHEREAS, the City Council of the City of Maitland finds it necessary and appropriate
19	to amend Chapter 8, Section 8-7.2(a) of the Code of Ordinances to conform to the exception
20	created by the Florida Legislature; and

22	WHEREAS, the City Council has determined that it is in the public interest to clarify the
23	rights and responsibility of residential property owners to cut down, destroy, remove, top or
24	relocate trees within the City of Maitland while still protecting healthy trees and promoting the
25	replacement of removed trees as necessary.

42	a. Tree removal permit. Except as provided in section 8-13-8-7.6, herein, no person shall cut
43 44	down, destroy, remove, top or relocate any tree without first obtaining a tree removal
44 45	permit from the city <u>unless such tree is located upon residential property and the property</u>
45	owner obtains documentation from an arborist certified by the International Society of
40	owner obtains documentation from an arborist certified by the international society of

Arboriculture or a Florida licensed landscape architect that the tree presents a danger to
persons or property as provided in Section 163.045, Florida Statutes. Work authorized by
the permit shall be accomplished within ninety (90) days of issuance of the permit.

51 SECTION 2. CODIFICATION. It is the intent of the City Council of the City of 52 Maitland that the provisions of this Ordinance shall be codified. The codifier is granted broad and 53 liberal authority in codifying the provision of this Ordinance.

55 SECTION 3. SEVERABILITY. If any section, sentence, phrase, word or portion of 56 this Ordinance is determined to be invalid, unlawful or unconstitutional, said determination shall 57 not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, 58 word or portion of this Ordinance not otherwise determined to be invalid, unlawful or 59 unconstitutional.

61 **SECTION 4. CONFLICTS.** In any case where a provision of this Ordinance is found 62 to be in conflict with a provision of any other ordinance of this City, the provision which 63 establishes the higher standards for the promotion and protection of the health and safety of the 64 people shall prevail. 65

SECTION 5. EFFECTIVE DATE. This Ordinance shall become effective immediately
upon its passage and adoption.
