

**ORDINANCE NO. 2023-O-015**

**AN ORDINANCE AMENDING THE JACKSONVILLE MUNICIPAL CODE,  
CHAPTER 3 ALCOHOLIC BEVERAGES, ARTICLE II RETAIL SALE,  
DIVISION 2 LICENSES, SECTION 3-64 LOCATION; CHANGE OF LOCATION;  
LIMITATIONS ON NUMBER ISSUED  
(Increase Class A, AA, B, BB, C, CC Club and  
Bowling Alley Licenses by one, total 48)**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JACKSONVILLE,  
MORGAN COUNTY, ILLINOIS:

SECTION 1: That Chapter 3 Alcoholic Beverages, Article II Retail Sale, Division 2 Licenses, Section 3-64 Location; change of location; limitations on number issued of the Municipal Code of the City of Jacksonville be amended by revoking Section 3-64(c) and substituting the following as a new Section 3-64(c):


(c) Limitation on number issued. No more than a total of forty-seven (48) Class "A," "AA," "B," "BB," "C," "CC," "Club" and "Bowling Alley" licenses shall be issued at any time. No more than one (1) "Fairgrounds-Fair Board" license and one (1) "Fairgrounds-Speedway" license shall be issued at any time. No more than nineteen (18) "D," "DD," "E," "EE," and "BH" licenses shall be issued at any time. No more than one (1) "CV" licenses shall be issued at any time. No more than two (2) "GP" licenses shall be issued at any time. No more than zero (0) "TH" licenses shall be issued at any time.

SECTION 2: That all ordinances, parts of ordinances, and amendments to ordinances in conflict with any provision of this ordinance are repealed as of the effective date hereof.

SECTION 3: That this ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.

SECTION 4: That the City Clerk is hereby instructed to publish this ordinance in pamphlet form.
