

## **ORDINANCE NO. 18685**

### **ORDINANCE ESTABLISHING THE COMPENSATION OF THE MAYOR AND CITY COUNCIL AND AMENDING SECTION 2-327 OF THE CODE OF ORDINANCES, CITY OF JOLIET, ILLINOIS**

**WHEREAS**, the Mayor and City Council of the City of Joliet, Illinois (City) has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs; and

**WHEREAS**, the City of Joliet is a home rule unit of local government.

**BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF JOLIET, ILLINOIS, PURSUANT TO ITS STATUTORY AND HOME RULE AUTHORITY, AS FOLLOWS:**

**SECTION 1:** That Chapter 2, Article X, Division 2, Section 327, shall be amended as follows:

#### **Sec. 2-327. – Compensation of Mayor and City Council and Liquor Commissioner.**


- (a) The Mayor of the City of Joliet shall receive compensation on an annual basis in accordance with the following schedule:
  - (1) Through May 2, 2027.....\$33,250.00
  - (2) After May 2, 2027.....\$40,250.00
- (b) The members of the City Council of the City of Joliet representing individual councilmanic districts shall receive compensation on an annual basis in accordance with the following schedule:
  - (1) Through May 2, 2027.....\$19,000.00
  - (2) After May 2, 2027.....\$23,000.00
- (c) The members of the City Council of the City of Joliet representing the City of Joliet at large shall receive compensation on an annual basis in accordance with the following schedule:
  - (1) Through May 4, 2025.....\$19,000.00
  - (2) After May 5, 2025.....\$23,000.00
- (d) The Liquor Commissioner of the City shall receive compensation on an annual basis in accordance with the following schedule:

After May 3, 1999 .....\$7,000.00
- (e) During their respective terms of office, the Mayor and members of the City Council shall receive the fringe benefits granted to Group I management employees for transportation cost reimbursement (at the applicable mileage rate), pension (IMRF), insurance benefits and deferred compensation. The Mayor and members of the City Council shall not continue to receive such fringe benefits after they leave office unless eligibility for such benefits has been earned through other service.

- (f) The salaries of the Mayor, the Liquor Control Commissioner, and the City Council Members shall be increased by 2% annually on January 1. This increase commences on January 1, 2028.
- (g) The Mayor, the Liquor Commissioner, and any member of the City Council may choose not to have his or her salary adjusted for any given year as set forth in this section by notifying the City Clerk in writing. This notification must be received by the City Clerk by December 15<sup>th</sup> for the choice to be effective for the following calendar year.
