ORDINANCE NO. 24-15

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF JUPITER, FLORIDA, AMENDING SECTION 27-373 WHICH ADOPTS AND INCORPORATES THE TOWN'S OFFICIAL ZONING MAP AS PART OF THE TOWN ZONING CODE; PROVIDING FOR THE ASSIGNMENT OF THE INDIANTOWN ROAD OVERLAY ZONING (IOZ) PINE GARDENS DISTRICT TO THE 24.6+/- ACRES OF LAND SHOWN ON THE MAP ATTACHED HERETO AND INCORPORATED HEREIN; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the owners of the various properties (the subject properties) whose properties, including the legal descriptions thereof are being rezoned to the Pine Gardens District of the IOZ are identified in Exhibit "A' which is attached hereto and incorporated herein; and

37 WHEREAS, the general location of the subject properties along Indiantown

38 Road, between Military Trail and Old Dixie Highway are shown on Exhibit "B"; and

WHEREAS, the subject properties currently have a zoning designation of
 Indiantown Overlay Zoning (IOZ) "Parkways" zoning district, with an underlying General
 Commercial (C-2) zoning; and

WHEREAS, the Town Council has previously adopted Ordinance No. 45-14,
 creating a new zoning district entitled the "Pine Gardens" district within the IOZ; and
 WHEREAS, the Town's Planning and Zoning staff has recommend the subject
 properties be assigned the IOZ "Pine Gardens" zoning district, with an underlying C-2
 zoning; and

6 WHEREAS, at a public hearing, the Jupiter Planning and Zoning Commission 7 reviewed the proposed assignment of the IOZ "Pine Gardens" zoning district which is to 8 be assigned to the subject properties; and

9 WHEREAS, at a public hearing of the Town Council the Council considered the 10 recommendations of the Town's Planning and Zoning Commission and the Planning and 11 Zoning Department regarding the proposed rezoning of the subject properties; and

12 WHEREAS, the Town Council determined that the subject properties should be 13 assigned the IOZ "Pine Gardens" zoning district, with an underlying C-2 zoning; and

14 WHEREAS, the Town Council finds that the assignment of the IOZ "Pine 15 Gardens" zoning district, with an underlying C-2 zoning to the subject properties is 16 consistent with the "Commercial" Future Land Use designation of the Town's 17 Comprehensive Plan.

18 NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE 19 TOWN OF JUPITER, FLORIDA:

20 Section 1. The whereas clauses are incorporated herein and represent the
 21 legislative findings of the Town Council.

22 <u>Section 2.</u> The Town Council hereby assigns the IOZ "Pine Gardens" zoning 23 district, with an underlying C-2 zoning to the subject properties. The assignment of the 24 IOZ "Pine Gardens" District to the subject properties shall be incorporated into the

Town's Official Zoning Map as shown in Figure "1", a copy of which is attached hereto
 and incorporated herein.

3 <u>Section 3.</u> Section 27-373 of the Zoning Code, the Town's Official Zoning
4 Map shall be amended to reflect the assignment of the IOZ "Pine Gardens" District to the
5 subject properties shown in the attached Figure 1.

Section 4. The Town Council has determined that the assignment of the IOZ
"Pine Gardens" District to the subject properties is consistent with the "Commercial"
Future Land Use designation assigned to the subject properties pursuant to the Town's
Comprehensive Plan.

<u>Section 5.</u> Severability. If any section, paragraph, sentence, clause, phrase
 or word of this Ordinance is for any reason held by a court to be unconstitutional,
 inoperative, or void, such holding shall not affect the remainder of this ordinance.

<u>Section 6.</u> Repeal of Laws in Conflict. All ordinances or part of ordinances in
 conflict herewith are hereby repealed to the extent of such conflict.

15 <u>Section 7</u>. The provisions of this Ordinance shall become effective upon
 16 adoption.
