### VILLAGE OF KENMORE BOARD OF TRUSTEES

Local Law No. 9, 2018

A Local Law Amending the Village of Kenmore Municipal Code Relating to Fences on Joined Parcels.  
Be it hereby enacted by the Board of Trustees of the Village of Kenmore as follows:

Section 1. The Village of Kenmore Municipal Code is hereby amended by adding Chapter 25, Zoning, Article VIII, Fences, Hedges, Trees, etc., Division 2, Fences, Sec. 25-181 to read in its entirety as follows:  
Sec. 25-181. use districts generally

(f) In the event of a re-subdivision, combining abutting parcels and/or creating a new lot, which includes a new lot rear yard consisting of portions of the front yard(s) of the former parcel(s), any fences located in the portion of the new lot rear yard that were front yard(s) of the former parcel(s) shall be limited to 3 feet in height.

(g) In no event shall a fence be put up to the street.

**Section 2.** Severability. If any section, subsection, subdivision, paragraph, clause, or phrase in this local law, or any part thereof, is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections or portions of this local law, or any part thereof. The Board of Trustees hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause, or phrase of this local law, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses, or phrases may be declared invalid or unconstitutional.

**Section 3.** This Local Law is effective upon filing with the Secretary of State in accordance with the Municipal Home Rule Law.
