ORDINANCE AMENDING CHAPTER 10 AMUSEMENTS AND ENTERTAINMENTS, ARTICLE IV REGULATIONS FOR LICENSEES OPERATING VIDEO GAMING TERMINALS SEC 10-83 NUMBER OF VIDEO GAMING LICENSED ESTABLISHMENTS OF THE NILES CODE OF ORDINANCES

WHEREAS, the Village President and Board of Trustees (hereinafter collectively referred to as the “Village Board”) of the Village of Niles, Cook County, Illinois (hereinafter the “Village”), find that the Village is a Home Rule Municipal Corporation as provided in Article VII, Section 6 of the 1970 Constitution of the State of Illinois and pursuant to said Constitutional Authority, may exercise and perform any function pertaining to its governmental affairs.

NOW, THEREFORE BE IT ORDAINED by the President and Board of Trustees of the Village of Niles, Cook County, Illinois, as follows:

SECTION 1: Chapter 10 Amusements and Entertainments, Article IV Regulations for Licensees Operating Video Gaming Terminals Sec 10-83 Number of Video gaming licensed establishments of the Niles Code of Ordinances, shall be amended as follows:

CHAPTER 10 Amusements and Entertainments

ARTICLE IV Regulations for Licensees Operating Video Gaming Terminals

Sec 10-83. Number of Video gaming licensed establishments.

(a) Twenty-seven gaming licenses are available to existing liquor license establishments that have been in existence ~~for a minimum of 12 months prior to the applicant's application date~~ and are in good stead with the Local Liquor Commissioner.


SECTION 2: That this Ordinance shall be in full force and effective after its passage, approval and publication in pamphlet form as provided by law.
