

ORDINANCE 2010-30

AN ORDINANCE AMENDING CHAPTER 98 TRAFFIC AND VEHICLES, ARTICLE III. VEHICLES LICENSES, SECTION 98-84 FEES, AND APPENDIX D FEE SCHEDULE IN THE CODE OF ORDINANCES, VILLAGE OF NILES

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Niles, Cook County, Illinois, as follows:

SECTION 1: Chapter 98 Traffic and Vehicles, Article III. Vehicles Licenses, Section 98-84 Fees, and Appendix D Fee Schedule shall be amended as follows:
