ORDINANCE AMENDING CHAPTER 98 TRAFFIC AND VEHICLES, ARTICLE I. IN GENERAL, SEC. 98-1 STATE VEHICLE CODE ADOPTED; EXCEPTIONS TO THE NILES CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED, by the President and the Board of Trustees of the Village of Niles, Cook County, Illinois, as follows:

SECTION 1: Chapter 98 Traffic and Vehicles, Article I. In General, Sec. 98-1 State vehicle code adopted; exceptions to the Niles Code of Ordinances shall be amended as follows:

CHAPTER 98 TRAFFIC AND VEHICLES

ARTICLE I. IN GENERAL

Sec. 98-1. State vehicle code adopted; exceptions.

~~(a) The state vehicle code (625 ILCS 5/1-100 et seq.), as may be amended from time to time in the manner provided by law, except as modified in this chapter, is hereby adopted by reference and incorporated in this chapter as if the vehicle code were fully set forth. In the event of a conflict, the provisions of this chapter shall prevail.~~

~~(b)~~ The following provisions of the state vehicle code are specifically not adopted The following provisions of the Illinois Motor Vehicle Code, Illinois Revised Statutes, Ch 625 ILCS, as amended from time to time, are hereby adopted by reference:

(e**b**) The provisions of the Illinois Vehicle Code incorporated herein shall be designated as the Niles Vehicle Code and shall be referred to as "Section 98-1." with reference to the appropriate section of the Illinois Vehicle Code.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of any such conflict.

SECTION 4: That any section or provision of this ordinance that is construed to be invalid or void shall not affect the remaining sections or provisions which shall remain in full force and effect thereafter.
