WHEREAS, Sections 2-392(6), 2-447, 2-458(a) and 2-459(a) of the Knoxville City Code authorize the Director of Human Resources to administer the City's classification and compensation plans; and

WHEREAS, the Director of Human Resources has submitted a proposed classification and compensation change to the Mayor to create the position of Police Assistant Chief, an unclassified/non-civil service position; and

WHEREAS, the Mayor has recommended this proposed change to the Council; and



NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF KNOXVILLE AS FOLLOWS:

SECTION 1: Chapter 2, Article III, Division 2, Section 2-450(6) of the Knoxville City Code is hereby amended by adding the following as a new and appropriately ordered row:
