

ORDINANCE NO. 22-09

**AN ORDINANCE AMENDING SECTION 17-26 THE MACOMB MUNICIPAL CODE
PERTAINING TO THE OFFICIAL ZONING MAP**

PREAMBLE

WHEREAS, the City of Macomb (the "City"), is a municipality duly organized under the laws of the State of Illinois; and

WHEREAS, under state and local law, the City Council of the City of Macomb, McDonough County, Illinois (the "Council"), has the power to pass all necessary ordinances, rules and regulations; and

WHEREAS, the City Attorney recommends to the Council for its consideration and approval an amendment to Chapter 17 Sections 26 of the Municipal Code of Macomb, Illinois (the "Code"); and

WHEREAS, The City has authority to adopt the amendments to the provisions of Chapter 17 of the Code in accordance with Illinois Municipal Code (65 ILCS 5/11-1-1); and

WHEREAS, the City Council finds it in the best interests of the City and desires to amend Chapter 17 Sections 26, as recommended by the City Attorney.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MACOMB, McDONOUGH COUNTY, ILLINOIS AS FOLLOWS:

Section 1. Incorporation of Preamble. The foregoing recitals are true and correct and are incorporated herein as the findings of the Mayor and City Council.

Section 2. Amendments. Chapter 17, Section 26 of the Municipal Code shall be amended as set forth in Exhibit A, attached to and incorporated into this Ordinance.

Section 3. Severability Clause. If any section, part or provision of this Ordinance is declared unconstitutional or invalid by a court of competent jurisdiction, then it is expressly provided and it is the intention of the City Council in passing this Ordinance that its parts shall be severable and all other parts of this Ordinance shall not be affected thereby and they shall remain in full force and effect.

Section 4. Effective Date. This Ordinance shall be effective upon its passage, approval and publication, as provided by law.





Exhibit A.

Sec. 17-26. – Official zoning map established.

The Official Zoning Map, which shall include the contiguous unincorporated area within one and one-half (1½) miles from the corporate city limits of Macomb, shall be amended, adopted by Ordinance, and published annually in accordance with the provisions of the Illinois Municipal Code. Said map shall include all amendments, changes or modifications made in the prior calendar year. The map prepared by General Planning and Resource Consultants, 730 De Mun Avenue, Saint Louis, Missouri, labeled "Plate `A' Macomb, Illinois Official Map," approved by the planning commission on April 22, 1970 is hereby established ~~[as] an official map for the City of Macomb, and the map prepared by consultants labeled "Plate `B' Macomb, Illinois Official Map," approved by the planning commission on April 22, 1970 is hereby established [as] an official map for the contiguous unincorporated area within one and one-half miles from the corporate limit of the City of Macomb, and are hereby made a part of this chapter.~~ Said official zoning maps shall be placed on file with the city clerk and shall be available at all times during business hours for public inspection and copies thereof shall be made available to all interested parties upon payment of the sum of ~~\$4.00~~ \$25.00 each, which amount is hereby determined to be adequate to reimburse the general fund of the city for the cost of printing and distributing same.
