

**THE FOLLOWING ORDINANCE WAS MOVED FOR INTRODUCTION BY COUNCIL MEMBER JOHN KELLER; SECONDED FOR INTRODUCTION BY COUNCIL MEMBER PULASKI.**

**ORDINANCE NO. 19-13**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MANDEVILLE AMENDING SECTION 9-31 OF THE CODE OF ORDINANCES, GARBAGE SERVICE CHARGES – LEVIED AND AMENDING ORDINANCE 19-02 INCREASING THE FEE LEVIED FOR SOLID WASTE AND RECYCLING COLLECTION AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH**

**WHEREAS**, on May 1, 2019, Coastal Environmental Services (CES) notified the City that the cost of processing and transportation of recyclable waste has increased from \$127.25 per ton to \$167.00 per ton, a 31% increase; and

**WHEREAS**, Section (N)(2) of the solid waste contract between CES and the City of Mandeville allows CES to petition the City for additional rate and price adjustments at reasonable times on the basis of material or unusual changes in its cost of operations, including but not limited to, changes in the cost of disposal; and

**WHEREAS**, CES has notified the City that recycling waste rates will be increased by \$.42 per home/unit which will be absorbed by the City of Mandeville; and

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Mandeville that the fees levied by the City of Mandeville for municipal solid waste collection and recycling be increased by the sum of \$.42 per month to \$17.18 per month per service unit, broken down as solid waste at \$12.80 and recycling at \$4.38 and this increase shall become effective June 1, 2019.

**BE IT FURTHER ORDAINED** that the Clerk of this Council be and she is hereby authorized and empowered to take any and all actions which she, in the exercise of her discretion, deems necessary to promulgate the provisions of this ordinance.


