

ORDINANCE NO. 7514

AN ORDINANCE AMENDING CERTAIN SECTIONS OF CHAPTER 31 OF THE CODE OF ORDINANCES, CITY OF MANHATTAN, KANSAS RELATING TO THE PARKING, STANDING, AND STOPPING OF VEHICLES IN THE CITY.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MANHATTAN, KANSAS:

Section 1. That Section 31-51 of Chapter 31 of the Code of Ordinances, City of Manhattan, Kansas, is hereby amended to read as follows:

Sec. 31-51. - Limited time parking zones.

- (a) In any 24-hour period, it is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on the same side of any street in the same block for a period or periods of time, the total of which is greater than the maximum period of time allowed by this section for parking on such block of such street. Parking, standing or stopping of a vehicle in any limited time parking zone shall only be allowed if such parking, standing or stopping is not in violation of any other provisions of the Code of Ordinances, City of Manhattan, Kansas and other applicable laws.
- (b) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection for longer than two hours.

Downtown District

All streets within the area described as beginning at the intersection of the north right-of-way of Humboldt Street and the east right-of-way of 2nd Street; thence south along the east right-of-way of 2nd Street to the south right-of-way of Houston Street; thence west along Houston Street to the east right-of-way of 4th Street; thence south to the south right-of-way of Pierre Street; thence west to the west right-of-way of 5th Street; thence north to the south right-of-way of Poyntz Avenue; thence west to the east right-of-way of 6th Street; thence north to the north right-of-way of Poyntz Avenue; thence east to the west right-of-way of 5th Street; thence north to the north right-of-way of Humboldt Street; thence east to the east right-of-way of 2nd Street and the point of beginning.

Poyntz Avenue

The north side of the 600 block of Poyntz Avenue.

- (c) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked

on any street in the locations specified in this subsection for longer than two hours except that this limitation shall not apply on Sundays.

5th Street

The east and west sides of North 5th Street between Humboldt Street and the alley between Humboldt Street and Poyntz Avenue.

- (d) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection for longer than 30 minutes.

Humboldt Street

The south side of Humboldt Street between a point 130 feet east of the east back-of-curb of the intersection of the south side of Humboldt Street and 5th Street and a point 160 feet west of the west back-of-curb of the intersection of the south side of Humboldt Street and 4th Street.

Leavenworth Street

The north and south sides of Leavenworth Street between 5th Street and 6th Street.

- (e) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection for longer than 15 minutes except that this limitation shall only apply on Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m.

Poyntz Avenue

The north side of Poyntz Avenue between a point 120 feet east of the east back-of-curb of the intersection of the north side of Poyntz Avenue and 8th Street and a point 285 feet east of said east back-of-curb of 8th Street.

- (f) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection for longer than three hours.

10th Street

Both sides of North 10th Street between Osage Street and Bluemont Street.

12th Street

The west side of North 12th Street between Laramie Street and Moro Street.

The east side of North 12th Street between Fremont Street and Moro Street.

14th Street

The east side of North 14th Street between Fremont Street and Laramie Street.

The west side of North 14th Street between Fairchild Avenue and Laramie Street.

16th Street

The east side of North 16th Street between Laramie Street and a point 110 feet south of the back-of-curb of the intersection of North 16th Street and Anderson Avenue.

Central Park Road

Both sides of Central Park Road within City Park between North 14th Street and Fremont Street, except where otherwise posted under the authority of the Director of Parks and Recreation Department.

East Park Road

Both sides of East Park Road within City Park, except where otherwise posted under the authority of the Director of Parks and Recreation Department.

Fairchild Avenue

The north side of Fairchild Avenue between North 14th Street and North 16th Street.

Fremont Street

The south side of Fremont Street between North 14th Street and a point 200 feet west of the west back-of-curb of the intersection of Fremont Street and North 11th Street.

The south side of Fremont Street between North 10th Street and North 11th Street.

Laramie Street

The south side of Laramie Street between North 10th Street and North Manhattan Avenue.

The north side of Laramie Street between North 10th Street and North 12th Street.

Moro Street

Both sides of Moro Street between North 10th Street and North Manhattan Avenue.

North Manhattan Avenue

The east side of North Manhattan Avenue between Fremont Street and Bluemont Avenue.

North Park Road

Both sides of North Park Road within City Park, except where otherwise posted under the authority of the Director of Parks and Recreation Department.

Old Anderson Avenue

Both sides of Old Anderson Avenue adjacent to the south side of Triangle Park between Anderson Avenue and North Manhattan Avenue.

Osage Street

Both sides of Osage Street between North 10th Street and North 11th Street.

Springboard Lane

Both sides of Springboard Lane within City Park, except where otherwise posted under the authority of the Director of Parks and Recreation Department.

Section 2. That Section 31-52 of Chapter 31 of the Code of Ordinances, City of Manhattan, Kansas is hereby amended to read as follows:

Sec. 31-52. - Limited time parking lots and no parking during designated times lots.

- (a) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any parking lot owned by the city or other publicly owned parking lot within the city in the following locations in excess of the periods of time allowed for parking prescribed herein or during the periods of time prescribed herein when parking a vehicle is unlawful:

The public parking lot south of the Library on the northeast corner of Juliette Avenue and Houston Street

This entire lot will be designated as free parking with a three-hour time limit, except for the 11 stalls on the west side of said parking lot next to Juliette Avenue, which will have a 30-minute time limit. These parking time limits shall only be applicable on Monday through Saturday between the hours of 6:00 a.m. and 9:00 a.m. and on Sunday from 1:00 p.m. to 6:00 p.m., provided that such restrictions shall not apply on any holidays.

The public parking lot on the south side of Humboldt Street between 3rd and 4th Streets

Except as set forth hereinafter, this entire lot will be designated as free parking and the south two parking rows shall be restricted with a two-hour time limit. All remaining parking rows shall be unrestricted as to the amount of time a vehicle can remain parked therein. The time limits on this parking lot shall apply on Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. The city manager is hereby authorized to designate up to eight parking stalls within this public lot for reserved use by public vehicles only. Such public vehicles may be owned and operated by public law enforcement, community corrections, the United States

Government, or any similar public agency or entity. Once designated, the city manager shall place signs within each such parking stall, clearly setting forth the public use to which such stall is reserved. Such stalls shall not be subject to the time restrictions set forth herein. Once posted, it shall be unlawful for any person to park a vehicle in violation of the reservation noted thereon.

The public parking lot on the north side of Houston Street, west of, and adjacent to 3rd Street

This entire lot shall be designated as free parking with the north two parking rows restricted with a two-hour time limit. All remaining parking rows shall be unrestricted as to the amount of time a vehicle can remain parked therein. The time limits on this lot shall only be applicable on Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m.

The public parking lots on the north side of Laramie Street, west of, and adjacent to 12th Street

These entire lots shall be designated as free parking with a three-hour time limit. The time limits on this lot shall only apply on Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m.

The public parking lot on the north side of the 1100 Block of Moro Street

The entire lot shall be designated as free parking with a three-hour time limit. The time limits on this lot shall only apply on Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m.

The public parking lot on the south and east sides of 227 Blue Earth Place

The 34 parking stalls in the center aisle on the south side and eight parking stalls immediately east of the drive thru lane of 227 Blue Earth Place shall be designated as free parking with a two-hour time limit. The time limits on this lot shall only apply on Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m.

The public parking lot adjacent to Town Center Mall

The entire lot is designated as free parking and shall not be restricted as to the amount of time within which a vehicle may be parked. However, it is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on this parking lot between the hours of 3:00 a.m. and 6:00 a.m. except for government vehicles, vehicles making deliveries to the stores located in Town Center Mall, vehicles used in cleaning, snow removal or maintenance of the parking lot or Town Center Mall, or vehicles with lawful permits issued and displayed pursuant to section 31-70 of this Code.

The public parking lot at the Manhattan Municipal Court Building

It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked

on this parking lot between the hours of 11:00 p.m. and 6:00 a.m. except for government vehicles and other vehicles authorized by the city.

The public parking lots within City Park adjacent to North Park Road

These entire lots shall be designated as free parking with a three-hour time limit, except that there shall be no parking between the hours of 3:00 a.m. and 6:00 a.m., and except where otherwise posted under the authority of the Director of Parks and Recreation Department.

The public parking lot within City Park adjacent to Wefald Pavilion and the public parking lot within City Park adjacent to the City Park Activity Center

These entire lots shall be designated as free parking with a three-hour time limit, except that there shall be no parking between the hours of 3:00 a.m. and 6:00 a.m., and except where otherwise posted under the authority of the Director of Parks and Recreation Department.

The public parking lot within City Park on the south side of and adjacent to Wilson Field

These entire lots shall be designated as free parking with a three-hour time limit, except that there shall be no parking between the hours of 3:00 a.m. and 6:00 a.m., and except where otherwise posted under the authority of the Director of Parks and Recreation Department.

The public parking lots within City Park adjacent to East Park Road

These entire lots shall be designated as free parking, except that there shall be no parking between 3:00 a.m. and 6:00 a.m., and except where otherwise posted under the authority of the Director of Parks and Recreation Department.

The public parking lots within City Park adjacent to Springboard Lane

These entire lots shall be designated as free parking, except that there shall be no parking between 3:00 a.m. and 6:00 a.m., and except where otherwise posted under the authority of the Director of Parks and Recreation Department.

The public parking lots within City Park adjacent to the City Pool

These entire lots shall be designated as free parking, except that there shall be no parking between 3:00 a.m. and 6:00 a.m., and except where otherwise posted under the authority of the Director of Parks and Recreation Department.

The public parking lots within City Park adjacent to and southwest of Larry Norvell Band Shell

These entire lots shall be designated as free parking, except that there shall be no parking between 3:00 a.m. and 6:00 a.m., and except where otherwise posted under the authority of the Director of Parks and Recreation Department.

The public parking lot within City Park adjacent to Baker Field

These entire lots shall be designated as free parking, except that there shall be no parking between 3:00 a.m. and 6:00 a.m., and except where otherwise posted under the authority of the Director of Parks and Recreation Department.

- (b) The city engineer or his/her designee is hereby authorized to post stop signs, yield signs, signs and other markers denoting no parking areas, reduced speed zone signs and markers and such other traffic control devices at all locations as he/she may deem necessary and appropriate within the boundaries of any parking lot owned by the city or other publicly owned parking lot within the city. From and after the placement of such traffic control devices, it shall be unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked in violation of such posted traffic control devices and any violation thereof and the penalty therefore shall be as prescribed for such violation by the Standard Traffic Ordinance for Kansas Cities, as adopted and amended by the city.

Section 3. That Section 31-53 of Chapter 31 of the Code of Ordinances, City of Manhattan, Kansas, is hereby amended to read as follows:

Sec. 31-53. – No Parking During Designated Times Zones.

- (a) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection except that this prohibition shall not apply on Sundays.

Browning Avenue

The east side of Browning Avenue between a point 150 feet north of the centerline of Claflin Road at the intersection of Claflin Road and the east side of Browning Avenue and a point 200 feet south of the centerline of Dickens Avenue at the intersection of Dickens Avenue and the east side of Browning Avenue.

College Avenue

The west side of College Avenue between Dickens Avenue and Hobbs Drive.

College Heights Road

The northerly side of College Heights Road beginning at a point 75 feet westerly of the west back of curb of the intersection of the northerly side of College Heights Road and College Avenue thence westerly 225 feet to a point 300 feet westerly of said west back of curb of College Avenue.

Dickens Avenue

The south side of Dickens Avenue beginning at the west back of curb at its intersection with Beechwood Terrace west to its intersection with Seth Child Road.

Fremont Street

The north side of Fremont Street between North 9th Street to North 11th Street.

Juliette Avenue

The east side of Juliette Avenue between Leavenworth Street and Humboldt Street.

The west side of Juliette Avenue between Houston Street and Colorado Street.

Poyntz Avenue

The north side of Poyntz Avenue between North 9th Street and North 10th Street.

The south side of the 900 block of Poyntz Avenue.

Sunset Avenue

The east side of Sunset Avenue between Sunset Lane and Delaware Avenue.

Yuma Street

The south side of Yuma Street between South 8th Street and South 9th Street.

- (b) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection from 3:00 AM to 6:00 AM.

10th Street

Both sides of North 10th Street between Osage Street and Bluemont Street.

12th Street

The west side of North 12th Street between Laramie Street and Moro Street.

The east side of North 12th Street between Fremont Street and Moro Street.

14th Street

The east side of North 14th Street between Fremont Street and Laramie Street.

The west side of North 14th Street between Fairchild Avenue and Laramie Street.

16th Street

The east side of North 16th Street between Laramie Street and a point 110 feet south of the back-of-curb of the intersection of North 16th Street and Anderson Avenue.

Central Park Road

Both sides of Central Park Road within City Park between North 14th Street and Fremont Street, except where otherwise posted under the authority of the Director of Parks and Recreation Department.

East Park Road

Both sides of East Park Road within City Park, except where otherwise posted under the authority of the Director of Parks and Recreation Department.

Fairchild Avenue

The north side of Fairchild Avenue between North 14th Street and North 16th Street.

Fremont Street

The south side of Fremont Street between North 14th Street and a point 200 feet west of the west back-of-curb of the intersection of Fremont Street and North 11th Street.

The south side of Fremont Street between North 10th Street and North 11th Street.

Laramie Street

The south side of Laramie Street between North 10th Street and North Manhattan Avenue.

The north side of Laramie Street between North 10th Street and North 12th Street.

Moro Street

Both sides of Moro Street between North 10th Street and North Manhattan Avenue.

North Manhattan Avenue

The east side of North Manhattan Avenue between Fremont Street and Bluemont Avenue.

North Park Road

Both sides of North Park Road within City Park, except where otherwise posted under the authority of the Director of Parks and Recreation Department.

Old Anderson Avenue

Both sides of Old Anderson Avenue adjacent to the south side of Triangle Park between Anderson Avenue and North Manhattan Avenue.

Osage Street

Both sides of Osage Street between North 10th Street and North 11th Street.

Springboard Lane

Both sides of Springboard Lane within City Park, except where otherwise posted under the authority of the Director of Parks and Recreation Department.

Poyntz Avenue

The north and south sides of Poyntz Avenue between 3rd Street and 6th Street.

- (c) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked

on any street in the locations specified in this subsection from 7:00 AM to 7:00 PM.

Stratton Circle

The entire south side of Stratton Circle.

- (d) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection from 12:00 AM to 9:00 AM.

Pioneer Lane

The north and west side of Pioneer Lane between Sunnyslope Lane and a point 145 feet north of the extended south property line of Lot 7 of the Revised Plat of the Campus View Addition to the City of Manhattan, Riley County, Kansas.

- (e) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection from 8:00 AM to 4:00 PM on any day when school is in session.

Hobbs Drive

The north side of Hobbs Drive between Browning Avenue and Vaughn Drive.

8th Street

The west side of 8th Street between Vattier Street and Bluemont Avenue.

- (f) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection from 8:00 AM to 4:30 PM on any day when school is in session.

Goodnow Avenue

The west side of Goodnow Avenue beginning 130 feet north of Goodnow Circle extending to Tecumseh Road.

- (g) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection from 8:00 AM to 5:00 PM.

14th Street

The west side of North 14th Street between Poyntz Avenue and Fairchild Avenue.

- (h) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked

on any street in the locations specified in this subsection from 8:00 AM to 12:00 PM on Monday through Friday.

Legore Lane

The east and west sides and northern terminus of Legore Lane between the northern terminus of Legore Lane and Claflin Road.

- (i) It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked on any street in the locations specified in this subsection from 12:00 AM to 12:00 PM on Sunday.

Poyntz Avenue

The north side of Poyntz Avenue between the east back-of-curb of the intersection of the north side of Poyntz Avenue and 8th Street and a point 120 feet east of said east back-of-curb of 8th Street.

Section 4. That Section 31-54 of Chapter 31 of the Code of Ordinances, City of Manhattan, Kansas, is hereby amended to read as follows:

Sec. 31-54. – No Parking at Any Time Zones.

It is unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or owned or operated by such person to be stopped, stood or parked at any time on any street in the following locations:

Allen Road

Both sides of Allen Road between Casement Road and Tuttle Creek Boulevard.

Allison Avenue

Both sides of Allison Avenue between its northernmost intersection with North Dondee Drive and its easternmost intersection with Stagg Hill Road near the intersection of Kansas Highway 18 and Kansas Highway 113.

The west side of Allison Avenue between its northernmost intersection with North Dondee Drive and its southernmost intersection with Stagg Hill Road.

Amherst Avenue

The entire north and west side of Amherst Avenue.

The south and east side of Amherst Avenue between the intersection of the south and east side of Amherst Avenue with Miller Parkway and a point 75 feet southeasterly of the centerline of E.J. Frick Drive at the intersection of E.J. Frick Drive and the south and east side of Amherst Avenue.

The south and east side of Amherst Avenue between points 160 feet westerly and 50 feet easterly of the centerline of Notre Dame Circle at the intersection of Notre Dame Circle and the south and east side of Amherst Avenue.

The south and east side of Amherst Avenue between points 100 feet westerly and 70 feet easterly of the centerline of Harvard Place at the intersection of Harvard Place and the south and east side of Amherst Avenue.

The south and east side of Amherst Avenue between points 250 feet westerly and 325 feet northeasterly of the centerline of Yale Circle at the intersection of Yale Circle and the south and east side of Amherst Avenue.

The south and east side of Amherst Avenue between points 155 feet southwesterly and 90 feet northeasterly of the centerline of South Dartmouth Drive at the intersection of South Dartmouth Drive and the south and east side of Amherst Avenue.

The south and east side of Amherst Avenue between a point 110 feet southwesterly of the centerline of Research Drive at the intersection of Research Drive and the south and east side of Amherst Avenue and the eastern terminus of Amherst Avenue.

Anderson Avenue

Both sides of Anderson Avenue between North Manhattan Avenue and the west city limits, except diagonal parking is allowed on the south side of Old Anderson Avenue, which is located in Aggieville and referred to as the Old Anderson Avenue cutoff, and parallel parking is allowed on the north side of Old Anderson Avenue, which is located in Aggieville and referred to as the Old Anderson Avenue cutoff.

Ardmore Drive

The west side of Ardmore Drive beginning at the intersection of Players Terrace and Players Circle proceeding south and east to the cul-de-sac.

Back Nine Circle

The entire west side of Back Nine Circle except for that portion contained within the circular cul-de-sac.

Baker's Way Avenue

The south side of Baker's Way Avenue between the east back-of-curb of its intersection with North Manhattan Avenue and a point 428 feet east of said east back of curb of North Manhattan Avenue.

The north side of Baker's Way beginning 604 feet east of its intersection with North Manhattan Avenue and a point 180 feet east of said east back of curb of North Manhattan Avenue.

Beechwood Terrace

The east side of Beechwood Terrace between the north back-of-curb of its

intersection with Claflin Road and a point 475 feet north of said north back-of-curb of Claflin Road.

The west side of Beechwood Terrace between the north back-of-curb of its intersection with Claflin Road and a point 118 feet north of said north back-of-curb of Claflin Road.

The west side of Beechwood Terrace beginning 230 feet north of the intersection with Claflin proceeding north 50 feet.

Bellerive Drive

The west side of Bellerive Drive between Tobacco Road and Players Terrace.

Bent Wood Drive

The entire north side of Bent Wood Drive.

Bertrand Street

The south side of Bertrand Street between North Manhattan Avenue and Juliette Avenue.

Blueline Circle

The east side of Blueline Circle between the south back-of-curb of its intersection with Buttonwood Drive and a point 220 feet south of said south back-of-curb of Buttonwood Drive.

Bluemont Avenue

Both sides of Bluemont Avenue between Hayes Drive and North Manhattan Avenue.

Bluemont Drive

The east side of Bluemont Drive between Ehler Road and Bluemont Circle.

Bluemont Scenic Drive

The south side of Bluemont Scenic Drive between Ehlers Road and Spring Hill Lane.

Both sides of Bluemont Scenic Drive between Spring Hill Lane and the Bluemont Scenic parking lot.

Brianna Court

The entire inside radius of Brianna Court.

Brook Lane

The entire inside northerly radius of Brook Lane between both of the intersections of Brook Lane and Butterfield Road.

The west side of Brook Lane between the intersection of Brook Lane and Butterfield Road and the intersection of Brook Lane and Brooklawn Drive.

Brookhaven Drive

The east side of Brookhaven Drive between Brookmont Drive and Brooklawn Drive.

Brooklawn Drive

The entire southerly side of Brooklawn Drive between Brook Lane and Brookmont Drive.

Brookpark Drive

The east side of Brookpark Drive between Northfield Road and Walters Drive.

Brookmont Drive

The south side of Brookmont Drive between the intersection of Brookmont Drive and Brook Lane and the intersection of Brookmont Drive and Brooklawn Drive.

Brookridge Drive

The south side of Brookridge Drive between Brookville West Drive and Brookville Drive.

Brookstone Circle

The south side of Brookstone Circle between the east back-of-curb of its intersection with Brookville Drive and a point 165 feet east of said east back of curb of Brookville Drive.

Brookstone Drive

The north side of Brookstone Drive between Brookpark Drive and Brookville Drive.

Brookville Drive and Brookville West Drive

The east side of Brookville West Drive between the intersection of Brookville West Drive and Walters Drive and the transition of Brookville West Drive to Brookville Drive and continuing thence along the south and westerly side of Brookville Drive between the transition of Brookville West Drive to Brookville Drive and the intersection of Brookville Drive and Northfield Road.

Brookway Drive

The north side of Brookway Drive between Brookville West Drive and Brookpark Drive.

Browning Avenue

The west side of Browning Avenue between Claflin Road and Kimball Avenue.

The north and west side of Ehlers Road between its southern terminus at the transition of North Juliette Avenue to Ehlers Road at the intersection of North Juliette Avenue and Ratone Street and the west back-of-curb of the intersection of the north and west side of Ehlers Road and Meadow Lane.

Elaine Drive

The entire east and south sides of Elaine Drive between the intersection of Elaine Drive and Todd Road and the intersection of Elaine Drive and Denison Avenue.

Eldridge Drive

The south and west side of Eldridge Drive between the north back-of-curb of its intersection with Colbert Hills Drive and its northernmost intersection with Grand Mere Parkway.

Enoch Road

Both sides of Enoch Road between McCall Road and the US-24 Highway right-of-way.

Everett Drive

The west side of Everett Drive between the extended south property line of Lot 10 of the Western Hills, Unit Eleven, Addition to the City of Manhattan, Riley County, Kansas, and the extended south property line of Lot 22 of the Western Hills, Unit Two, Addition to the City of Manhattan, Riley County, Kansas.

Evergreen Avenue

The west side of North Evergreen Avenue between Poyntz Avenue and Sunset Avenue.

The east side of North Evergreen Avenue between the north back-of-curb of its intersection with Poyntz Avenue and a point 100 feet north of said north back-of-curb of Poyntz Avenue.

Highland Ridge Drive

The west side of Scenic Crossing beginning at Anderson Avenue proceeding north to Scenic Court.

Scenic Landing

The east and west sides of Scenic Landing from the intersection of Anderson Avenue north to the intersection of Scenic Crossing.

Sheffield Circle

Both sides of Sheffield Circle between the southern terminus of both sides of Sheffield Circle and points 200 feet north of said southern terminus of Sheffield Circle.

Shuss Road

Both sides of Shuss Road between Southwind Road and Johnson Valley Drive.

Snowbird Drive

The north and east side of Snowbird Drive between a point 80 feet south of the south back-of-curb of the intersection of the north and east side of Snowbird Drive and Tamarron Terrace and a point 246 feet south and east of said point 80 feet south of said south back-of-curb of Tamarron Terrace.

Society Circle

The entire easterly side of Society Circle except for that portion contained within the circular cul-de-sac.

Stagg Hill Road

Both sides of Stagg Hill Road along its entire length within the city limits.

Stone Crest Court

Along the east curb of Stone Crest Court, from 150 feet south of the intersection with Stone Crest Drive, to 190 feet south of the intersection with Stone Crest Drive.

Stone Drive

Along the south and west curb of Stone Drive from the intersection of Scenic Drive, west 190 feet.

Stone Pointe Drive

Along the east side of Stone Pointe Drive, from the intersection with Stone Drive, north 60 feet.

Along the east side of Stone Pointe Drive, from the intersection with Highland Ridge Drive, south 50 feet.

Stonewood Drive

The south side of Stonewood Drive between Juniper Drive and Kingwood Drive.

Stratton Circle

The entire north side of Stratton Circle.

The rounded cul-de-sac western terminus of Stratton Circle.

Sumac Drive

The entire south side of Sumac Drive.

The north side of Sumac Drive between the east back-of-curb of its intersection with Juniper Drive and a point 300 feet east of said east back-of-curb of Juniper Drive.

Sundance Drive

The entire south and west side of Sundance Drive.

Sunnymeade Road

The entire east side of Sunnymeade Road.

Sunnyslope Lane

The east side of Sunnyslope Lane between Thomas Circle and Country Club Road/10th Street.

The west side of Sunnyslope Lane between Vista Lane and Pioneer Lane.

Sunset Avenue

The west side of Sunset Avenue between Poyntz Avenue and Claflin Road.

The east side of Sunset Avenue between Poyntz Avenue and Sunset Lane.

The east side of Sunset Avenue between Delaware Avenue and Claflin Road.

Sunset Lane

Both sides of Sunset Lane between Sunset Avenue and Delaware Avenue.

Tecumseh Road

The north side of Tecumseh Road between Wharton Manor Road and the transition of Platt Street to Tecumseh Road at the intersection of Quivera Drive and Platt Street/Tecumseh Road.

Thurston Street

The south side of Thurston Street between 3rd Street and 5th Street.

The south side of Thurston Street between 11th Street and Manhattan Avenue.

Tobacco Circle

The entire south side of Tobacco Circle except for that portion contained within the circular cul-de-sac.

Tobacco Road

The south side of Tobacco Road between the west back-of-curb of its intersection with Bellerive Drive and a point 302 feet west of said west back-of-curb of Bellerive Drive.

The north and east side of Tobacco Road between a point 302 feet west of the centerline of Bellerive Drive at the intersection of Bellerive Drive and the north side of Tobacco Road and the northern terminus of Tobacco Road.

Travers Circle

The south side of Travers Circle beginning at the southwest back of curb proceeding west then south to the cul de sac.

Turnberry Circle

The west side of Turnberry Circle beginning at the intersection of Colbert Hills Drive except for the portion contained within the circular cul-de-sac.

University Drive

Both sides of University Drive between the northern terminus of both sides of University Drive and points 200 feet south of said northern terminus of University Drive.

East side of University Drive beginning at the north back of curb at Claflin Road proceeding north to Todd Road.

Vanesta Drive

The north and west side of Vanesta Drive between a point 270 feet east of the east back-of-curb of the intersection of Back Nine Circle and the north side of Vanesta Drive and a point 425 feet south of the south back-of-curb of the intersection of Colbert Hills Drive and the west side of Vanesta Drive.

Vattier Street

The south side of Vattier Street between 11th Street and Manhattan Avenue.

Vista Lane

The entire south and east side of Vista Lane.

Walters Drive

Along the south curb of Walters Drive, from its intersection of Brookville West Drive, east 40 feet.

The north side of Walters Drive between Butterfield Road and Brookville West Drive.

Wharton Manor Road

The east side of Wharton Manor Road beginning at its intersection with Claflin Road to a point 395 feet south of Claflin Road.

The east side of Wharton Manor Road beginning at its intersection with Tecumseh Road to a point 85 feet north of Tecumseh Road.

The west side of Wharton Manor Road beginning at its intersection with Claflin Road south to the intersection of Tecumseh Road.

Waters Street

The east side of Waters Street between Anderson Avenue and Shaffer Street.

Westport Drive

Both sides of Westport Drive between Anderson Avenue and Claflin Road.

Westview Drive

Both sides of Westview Drive from the intersection of Anderson Avenue, south 60 feet.

The west side of Westview Drive beginning at its intersection with Anderson Avenue to a point 440 feet south of Anderson Avenue.

Westwood Road

Both sides of Westwood Road between Pine Drive and Oak Street.

The east side of Westwood Road between Oak Street and Fort Riley Boulevard.

Wildwood Lane

Both sides of Wildwood Lane along its entire length within the city limits.

Wreath Avenue

The west side of Wreath Avenue between Anderson Avenue and Dickens Avenue.

Both sides of Wreath Avenue between Dickens Avenue and Kimball Avenue.

Yuma Street

The south side of Yuma Street between 5th Street and 8th Street.

The south side of Yuma Street between the west back-of-curb of its intersection with 9th Street and a point 140 feet west of said west back-of-curb of 9th Street.

The south side of Yuma Street between 10th Street and 16th Street.

The north side of Yuma Street between the west back-of-curb of its intersection with 9th Street and a point 20 feet west of the west back-of-curb of 10th Street.

3rd Street

Both sides of 3rd Street between Pierre Street and Leavenworth Street.

Both sides of 3rd Street between Bluemont Avenue and Tuttle Creek Boulevard/US Highway 24.

4th Street

The east side of 4th Street between Bluemont Avenue and Vattier Street.

The west side of 4th Street between Bluemont Avenue and the alley between Bluemont Avenue and Vattier Street.

Both sides of 4th Street beginning at the south back of curb of the intersection of 4th Street and Yuma Street thence south to the intersection of 4th Street and the Union Pacific Railroad right-of-way lying between Fort Riley Boulevard and Pottawatomie Avenue.

5th Street

The west side of 5th Street between Poyntz Avenue and Houston Street.

The east side of 5th Street between Houston Street and Pierre Street.

10th Street

Both sides of 10th Street between Fort Riley Boulevard and the alley between Fort Riley Boulevard and Yuma Street named El Paso Lane.

The east side of 10th Street between Pierre Street and a point 150 feet north of the north back-of-curb of the intersection of the east side of 10th Street and Poyntz Avenue.

The west side of 10th Street between the southernmost intersection of 10th Street and Pottawatomie Avenue and the Union Pacific Railroad right-of-way lying between Fort Riley Boulevard and Pottawatomie Avenue.

11th Street

The west side of 11th Street, from the intersection of the west curb on 11th Street and the south curb on Bertrand Street, south 40 feet.

The west side of 11th Street, from the intersection of the west curb on 11th Street and the south curb of Vattier Street, south 40 feet.

Both sides of 11th Street between Poyntz Avenue and Bluemont Avenue.

The west side of 11th Street between Poyntz Avenue and Houston Street.

The east side of 11th Street between Poyntz Avenue and the alley between Poyntz Avenue and Houston Street.

The east side of 11th Street between Bluemont Avenue and Bertrand Street.

12th Street

The west side of 12th Street between Fremont Avenue and a point 150 feet north of the north back-of-curb of the intersection of the west side of 12th Street and Laramie Street.

The east side of 12th Street between Bertrand Street and Ratone Street.

14th Street

Both sides of 14th Street between Laramie Street and Anderson Avenue.

The east side of 14th Street between the south back-of-curb of the intersection of the east side of 14th Street and Fremont Street and a point 140 feet south of said south back-of-curb of Fremont Street.

The east side of 14th Street between the south back-of-curb of the intersection of the east side of 14th Street and Central Park Road and a point 150 feet south of said south back-of-curb of Central Park Road.

16th Street

The east side of 16th Street between the north back-of-curb of the intersection of the east side of 16th Street and Poyntz Avenue and a point 150 feet north of said north back-of-curb of Poyntz Avenue.

The east side of 16th Street between the south back-of-curb of the intersection of the east side of 16th Street and Anderson Avenue and a point 110 feet south of said south back-of-curb of Anderson Avenue.

The west side of 16th Street between Leavenworth Street and Anderson Avenue.

17th Street

Both sides of 17th Street between Fort Riley Boulevard and Anderson Avenue.

Section 5. That Division 4, Section 31-71 of Chapter 31 of the Code of Ordinances, City of Manhattan, Kansas, is hereby amended to read as follows:

DIVISION 4 - AGGIEVILLE RESIDENT PARKING PERMITS

Sec. 31-71. – “Fuchsia Aggieville Resident Zone” parking permit for city parking lots and streets in the Aggieville area.

- (a) Any person who is a resident of real estate which is within the area north of Fremont Street between North 11th Street and North 14th Street and south of Bluemont Avenue between North 11th Street and North 14th Street, is eligible to apply for a permit, which allows the person to park a vehicle in the locations described in subsection (c) during the times and days that may be restricted under Section 31-51 through 31-53.
- (b) Any person owning or leasing real estate which abuts the streets described in subsection (c)(4-8) or abuts the north side of Fremont St between North 10th Street and North 11th Street is eligible to apply for a permit, which allows the person to park a vehicle in the locations described in in subsection (c) during the times and days that may be restricted under Sections 31-51 through 31-53.
- (c) Restrictions described in Sections 31-51, 31-52, and 31-53 shall not apply to a vehicle that has properly displayed thereon a valid and current "Fuchsia Aggieville Resident Zone" permit in the following locations:
 - (1) The public parking lot within City Park adjacent to Wefald Pavilion and the public parking lot within City Park adjacent to the City Park Activity Center.
 - (2) The public parking lots within City park adjacent to the City Pool.
 - (3) The south side of Fremont Street between North 14th Street and a point 200 feet west of the west back-of-curb of the intersection of Fremont Street and North 11th Street.
 - (4) Both sides of North 10th Street between Osage Street and Bluemont Avenue.
 - (5) The south side of Fremont Street between North 10th Street and North 11th Street.
 - (6) Both sides of Laramie Street between North 10th Street and North 11th Street.
 - (7) Both sides of Moro Street between North 10th Street and North 11th Street.
 - (8) Both sides of Osage Street between North 10th Street and North 11th Street.

- (d) Fuchsia Aggieville Resident Zone permitted vehicles are not exempt from any other restriction or regulation of parking posted in City Park streets or parking lots under the authority of the Director of Parks and Recreation Department.
- (e) Only one permit shall be issued for any person eligible under subsection (a) and only two permits shall be issued for any one dwelling unit under subsection (b). All other terms and conditions of the Fuchsia Aggieville Resident Zone permit process shall be as described in Sections 31-135 through 31-140.

Secs. 31-72 – 31-100. – Reserved.

Section 6. Appropriate regulatory signs shall be erected to reflect the restrictions set forth herein.

Section 7. All other Ordinances or portions thereof, in conflict herewith are hereby repealed.

Section 8. This ordinance shall take effect Friday, January 1, 2021, and after its publication in *The Manhattan Mercury*.

ORDINANCE NO. 7514 SUMMARY

On December 1, 2020, the City of Manhattan, Kansas adopted the following ordinance:

AN ORDINANCE AMENDING CERTAIN SECTIONS OF CHAPTER 31 OF THE CODE OF ORDINANCES, CITY OF MANHATTAN, KANSAS RELATING TO THE PARKING, STANDING, AND STOPPING OF VEHICLES IN THE CITY.

This ordinance amends street and parking lot parking regulations within City Park, Aggieville District, and surrounding areas, including creating a new resident permit zone, “Fuchsia Aggieville Resident Zone,” in certain areas surrounding the Aggieville District.
