Chapter 8, at Section 8-14 is amended as follows:



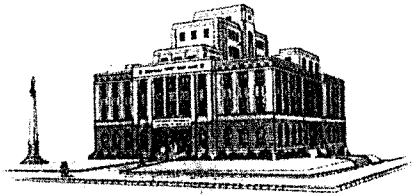

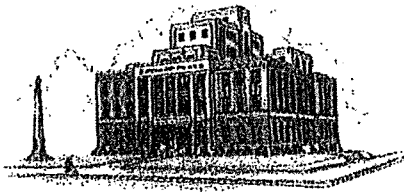

If these locations are within your prospective **Ward 4** District lines, we would appreciate you considering also making these changes to avoid confusion since the voter registration card also reflects City Ward locations.

We will be mailing out voter registration cards to **410** and **411** voters notifying them of these new precinct locations.
