**AN ORDINANCE TO AMEND SECTIONS 12-7, 12-8, 12-9 & 12-10 OF THE CODE OF LAWS
OF THE CITY OF NEWBERRY, SOUTH CAROLINA.**

BE IT ORDAINED by the governing body of the City of Newberry, South Carolina,
in Council duly assembled this 10th day of December 2019, that Sections 12-7, 12-8, 12-9
& 12-10 of Chapter 12 of the Code of Laws of the City of Newberry, South Carolina is
hereby amended to read as follows:

CHAPTER 12. PARKS AND RECREATION

Sec. 12-7. Firehouse conference center – facility rental rates.

The facility rental rates for the Firehouse Conference Center are as set forth
