AN ORDINANCE of the CITY OF MINNEAPOLIS

Mead

presents the following ordinance:

Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances relating to Traffic Code: Parking, Stopping and Standing.

The City Council of The City of Minneapolis do ordain as follows:

Section 1. That Section 478.730 of the above-entitled ordinance be amended by adding thereto the following Loading Zones:

No. 3356 – Both sides of LaSalle Av betw the limits of W 14th St & Oak Grove St (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3357 – Both sides of Spruce Pl betw W Grant St & W 14th St (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3358 – Wly side of Spruce Pl betw W 14th St & W 15th St (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3359 – Both sides of Spruce Pl betw W 15th St & Oak Grove St (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3360 – Wly side of Willow St betw W Grant St & W 15th St (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3361 – Both sides of Oak Grove St from LaSalle Av Ely to the dead end Ely of LaSalle Av (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3362 – Sly side of W 15th St betw Oak Grove St & LaSalle Av (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3363 – Nly side of W 15th St beginning 264 ft Ely of the Ely curb line of Oak Grove St produced and thence extending Ely to Spruce Pl (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3364 – Sly side of W 14th St betw Willow St & Spruce PI (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3365 – Nly side of Oak Grove St betw LaSalle Av & Spruce PI (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit);

No. 3366 – Sly side of W 14th St beginning 130 ft Ely of the Ely curb line of Spruce PI and thence extending to LaSalle Av (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit); and

No. 3367 – Nly side of W 14th St betw LaSalle Av & Spruce PI (Critical Parking Area #15) (Loading Zone, Two Hour Parking, 9AM-4PM, Monday-Friday, Except by Permit).
