**Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances
relating to Traffic Code: Parking, Stopping and Standing.**

The City Council of The City of Minneapolis do ordain as follows:

Section 1. That Section 478.730 of the above-entitled ordinance be amended by adding thereto the following Loading Zones:

No. 3374 - SEly side of Grove St beg at W Island Av and thence extending 260 ft NEly (Critical Parking Area #16) (Loading Zone, Two Hour Parking 8 AM-6 PM, Daily Except by Permit);

No. 3375 - NEly side of W Island Av beg at Grove St and thence extending NWly to the railroad tracks clearance area (Critical Parking Area #16) (Loading Zone, Two Hour Parking 8 AM-6PM, Daily Except by Permit);

No. 3376 - NEly side of W Island Av beg 584 ft NWly of the NWly curb line of Grove St and thence extending to Maple Pl (Critical Parking Area #16) (Loading Zone, Two Hour Parking 8 AM-6 PM, Daily Except by Permit);

No. 3377 - NEly side of W Island Av beg at the NWly side of Maple Pl and thence extending 186 ft NWly (Critical Parking Area #16) (Loading Zone, Two Hour Parking 8 AM-6 PM, Daily Except by Permit);

No. 3378 - SWly side of E Island Av beg at the SEly side of Maple Pl and thence extending 362 ft SEly (Critical Parking Area #16) (Loading Zone, Two Hour Parking 8 AM-6 PM, Daily, Except by Permit);

No. 3379 - SEly side of Maple Pl between W Island Av and E Island Av (Critical Parking Area #16) (Loading Zone, Two Hour Parking 8 AM-6 PM, Daily, Except by Permit);

No. 3380 - NEly side of Nicollet St beg at the SEly side of Maple Pl and thence extending 213 ft SEly (Critical Parking Area #16) (Loading Zone, Two Hour Parking 8 AM-6 PM, Daily, Except by Permit);
