**Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances relating to Traffic Code: Parking, Stopping and Standing.**

The City Council of The City of Minneapolis do ordain as follows:

Section 1. That Section 478.730 of the above-entitled ordinance be amended by adding thereto the following Loading Zones:

No. 3432 - Both sides of Douglas Av between Hennepin Av and Dupont Av S (Critical Parking Area #23) (Loading Zone, Two Hour Parking, 8 AM-8 PM, Monday-Friday, Except by Permit);

No. 3433 - Both sides of Summit Av between Bryant and Dupont Av S (Critical Parking Area #23) (Loading Zone, Two Hour Parking, 8 AM-8 PM, Monday-Friday, Except by Permit);

No. 3434 - Nly side of Summit Av between Hennepin Av and Bryant Av S (Critical Parking Area #23) (Loading Zone, Two Hour Parking, 8 AM-8 PM, Monday-Friday, Except by Permit);

No. 3435 - Both sides of Lincoln Av between Hennepin Av and Dupont Av S (Critical Parking Area #23) (Loading Zone, Two Hour Parking, 8 AM-8 PM, Monday-Friday, Except by Permit);

No. 3436 - Both sides of Bryant Av S between Lincoln Av and Douglas Av (Critical Parking Area #23) (Loading Zone, Two Hour Parking, 8 AM-8 PM, Monday-Friday, Except by Permit);

No. 3437 - Both sides of Colfax Av S between Lincoln Av and Mt Curve Av (Critical Parking Area #23) (Loading Zone, Two Hour Parking, 8 AM-8 PM, Monday-Friday, Except by Permit);

No. 3438 - Both sides of Dupont Av S between Lincoln Av and Mt Curve Av (Critical Parking Area #23) (Loading Zone, Two Hour Parking, 8 AM-8 PM, Monday-Friday, Except by Permit);

No. 3439 - Wly side of Hennepin Av from Douglas Av to Lincoln Av (Critical Parking Area #23) (Loading Zone, Two Hour Parking, 8 AM-8 PM, Monday-Friday, Except by Permit).
