Amending Title 12, Chapter 242 of the Minneapolis Code of Ordinances relating to Housing: Appeals.

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Section 242.50 of the above entitled ordinance be amended to read as follows:

242.50. Duties and responsibilities of board. The housing board of appeals shall hear and act upon all appeals except as its jurisdiction has been limited by section 242.80. The board may modify or sustain or quash all or any portion of any order; interpretation; requirement; decision or other determination made by a duly authorized representative of the city in matters of enforcement of the housing maintenance code and all other city codes affecting existing buildings.

In acting upon such appeals the board shall broadly utilize its reasoned discretion in the framework of all relevant facts presented to it for consideration at the hearing of such appeal. Such facts may include, but not by way of limitation: Past, present and future occupancy of the building; practical economic life of the building in its present use and/or any practicable alternative use; architectural characteristics of the building; existing and/or probable future characteristics of the surrounding neighborhood; and any other matter or matters useful to a reasoned balancing between the public objectives underlying the codes being enforced and the probable economic and social consequences to all persons directly or indirectly concerned if such order or other determination is sustained, modified or quashed.

Section 2. That Section 242.80 of the above entitled ordinance be amended by adding a new paragrpah (g) thereto to read as follows:

242.80. Limitations on jurisdiction of board.

(g) To quash or modify any order or decision enforcing the Minneapolis Building Code with respect to any building or portion thereof.
