AN ORDINANCE of the CITY OF MINNEAPOLIS

presents the following ordinance:

Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances relating to Traffic Code: Parking, Stopping and Standing.

The City Council of The City of Minneapolis do ordain as follows:

Section 1. That Section 478.590 of the above-entitled ordinance be amended by adding thereto the following No Parking Zones:

No. 6102 - Cul-de-sac on 19th Av SE Nly of Talmadge Av SE beginning on Ely side of 19th Av SE, 133' Nly of Nly curb line of Talmadge Av SE & thence extending around the cul-de-sac (No Parking Anytime).

No. 6103 - Nly side of Lagoon Av beginning 204' from Wly curb line of Fremont Av S & thence extending 340' Wly (No Parking, Bus Stop).

No. 6104 - Nly side of Lagoon Av, beginning at Wly curb line of Hennepin Av & thence extending 129' Wly (No Parking, Bus Stop).

No. 6105 - Nly side of Lagoon Av, beginning at Wly curb line of Irving Av S & thence extending 100' Wly (No Parking, Bus Stop).
