BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, DECEMBER 5, 2023 AT SEVEN O'CLOCK P.M.

On motion of Mr. Everhardt, seconded by Mr. McCloskey, it was moved to **adopt** the following ordinance:

AN ORDINANCE TO AUTHORIZE THE PARISH PRESIDENT TO ACCEPT THE DONATION OF CERTAIN PROPERTY FOR ANIMAL SHELTER OPERATIONS FROM THE ARLENE & JOSEPH MERAUX CHARITABLE FOUNDATION AND TO EXECUTE ANY NECESSARY ANCILLARY DOCUMENTS FOR THE DONATION.

WHEREAS, the Arlene & Joseph Meraux Charitable Foundation wishes to donate certain property to St. Bernard Parish Government for operation of its Animal Shelter, said property being more particularly described in the Act of Donation attached to this Ordinance.

WHEREAS, it is in the best interest of St. Bernard Parish to accept this donation.

#### ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The property at issue is fully described in the Act of Donation, which is attached hereto as Exhibit A. This property will be referred to hereinafter in this ordinance as "THE PROPERTY".

**SECTION 2.** The St. Bernard Parish Council hereby authorizes the Parish President to accept the donation of THE PROPERTY, from the Arlene & Joseph Meraux Charitable Foundation and to execute the Act of Donation (Exhibit A) and any documents necessary to effectuate the donation.

**SECTION 3.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.
