AN ORDINANCE TO DECLARE AS SURPLUS 2113 MARGARET LANE, WHICH HAS BEEN ADJUDICATED TO THE PARISH, AND TO AUTHORIZE THE SALE OF SAID PROPERTY TO PAUL & SUSAN TROSCLAIR.

ST. BERNARD PARISH COUNCIL, THE GOVERNING AUTHORITY, DOES HEREBY FIND IT NECESSARY AND IN THE PUBLIC INTEREST TO ORDAIN:

Whereas, the property located at 2113 Margaret Lane was adjudicated to the Parish on June 23, 2010; and,

Whereas, the Parish considers this property surplus and it is not needed for a public purpose; and,

Whereas, the Parish has received a qualifying offer to purchase the property.

SECTION 1. The following adjudicated property is surplus and is not needed for any public purpose:

2113 Margaret Lane
Meraux, Louisiana 70075
LOT 4 SQ D St. Bernard Grove 50 X 150 = 7500

This property will be referred to hereinafter in this ordinance as "2113 Margaret Lane".

SECTION 2. 2113 Margaret shall be sold in accordance with law (La.R.S. 47:2201 et seq., specifically, La.R.S. 47:2202A & La.R.S. 47:2206, as well as the St. Bernard Parish Adjudicated Surplus Properties Program (Ordinance SBPC# 1378-03-13).




