## **ORDINANCE NO. 2719NS**

AN ORDINANCE AMENDING PORTIONS OF CHAPTER 22, DIVISION 2, SECTION 22-744 - TERM OF OFFICE - OF THE SHAWNEE CITY CODE OF ORDINANCES, BY AMENDING CHAPTER 22 DEFINING THE TERM OF OFFICE; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR EMERGENCY CLAUSE.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COMMISSIONERS OF THE CITY OF SHAWNEE, OKLAHOMA THAT CHAPTER 25 OF THE CITY CODE OF ORDINANCES BE AMENDED AS FOLLOWS:

**SECTION 1.** That Chapter 22, Division 2, Section 22-744 of the Code of the City of Shawnee, Oklahoma, is hereby amended to read as follows:

## DIVISION 2. – ESTABLISHMENT OF ARTS & CULTURE COMMISSION

§22-744. Term of Office. The terms of the four (4) professional members of the Shawnee City Arts & Culture Commission shall be three years or until his/her successor takes office, not including partial terms. The terms of the remaining three (3) members (organizational and at large) shall be two (2) years or until his/her successor takes office, not including partial terms. No member shall serve more than three consecutive terms. Members who have served three consecutive terms may be reappointed after having rotated off the Commission for at least one full term.

**SECTION 2: REPEALER.** All sections, subsections, clauses, and sentences of existing law in conflict with this ordinance are repealed.

**SECTION 3: CODIFICATION.** This Ordinance shall be codified in the Shawnee Municipal Code, and the codifier is authorized to set out the ordinance as appropriate.

**SECTION 4: SEVERABILITY.** The provisions of this ordinance are severable and, if any sentence, provision, or other part of this Ordinance shall be held invalid, the decision of the court so holding shall not affect or impair any of the remaining parts or provisions of this ordinance.

**SECTION 5: EMERGENCY.** It being immediately necessary for the preservation of the peace, health, safety and public good of the City of Shawnee, Oklahoma and the inhabitants thereof that the provisions of this Ordinance be put into full force and effect, an emergency is hereby declared to exist, by reason whereof, this ordinance shall take effect and be in full force and effect after its passage, as provided by law.
