On motion of Mr. Coen, seconded by Ms. Bohmke, which carried by a vote of 7 to 0, the following was adopted:

AN ORDINANCE TO AMEND AND REORDAIN STAFFORD
COUNTY CODE SEC. 9-34, "DESIGNATED" AND SEC. 9-58,
"LOCATION"

WHEREAS, County Code Sec. 9-34 specifies Ferry Farm Elementary School as the designated polling place for the Ferry Farm precinct in the George Washington Election District; and

WHEREAS, Ferry Farm Elementary School will be undergoing renovation in 2020 and will no longer be a suitable polling place; and

WHEREAS, County Code Sec. 9-58 designates the Stafford Administration Center as the Central Absentee Election District location; and

WHEREAS, the Registrar has requested the location of the Central Absentee Election District be updated to coincide with the location of the Registrar's Office; and

WHEREAS, the Board has carefully considered the recommendation of the Registrar and testimony, if any, received at the public hearing; and

WHEREAS, the Board desires to update the County Code to reflect these changes;

NOW, THEREFORE, BE IT ORDAINED by the Stafford County Board of Supervisors on this the 17th day of December, 2019, that Stafford County Code Sec.

9-34, “Designated” and Sec. 9-58, “Location,” be and they hereby are amended and reordained as follows, with all other portions remaining unchanged:

Sec. 9-34. – Designated.

Pursuant to authority contained in Virginia Code §§ 24.2-306—24.2-310, the voting precinct for each election district and the polling place for each precinct shall be as follows:

Sec. 9-58. – Location.

The Central Absentee Voter Election District shall be located at the Office of the General Registrar of Stafford County, Virginia. Administration Center, 1300 Courthouse Road, Stafford, Virginia.
