

Bill No. 4228, an Ordinance of the City of Wentzville, Missouri, Amending Section 320.050 – Special Speed Limits on Roadways Within Chapter 320 – Speed Regulations, Schedule VII and Section 397.110 - Table VII-A – School Speed Zones Within Chapter 397 – Traffic Schedules of the Municipal Code of the City of Wentzville for the Regulation of Speed on Roadways Adjacent to Schools.

WHEREAS, in order to clarify school speed limits and to enable more effective enforcement, the City of Wentzville, Missouri (the "City"), has determined that it is beneficial to establish time based school speed limits; but, to also provide flexibility for additional speed regulation in conformity with posted signs.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WENTZVILLE, MISSOURI, AS FOLLOWS:

Section 1: Subsection (b) of Section 320.050 of Chapter 320 - Speed Regulations of Chapter 320 the Municipal Code regarding special speed limits on roadways within designated school zones shall be amended as follows:

Section 320.050. - Special Speed limits on roadways.

(b) No person shall operate a motor vehicle upon those portions of the roadways **adjacent to schools** that are set forth and described in Schedule VII, Table VII-A, of Chapter 397 at a rate of speed in excess of 20 miles per hour from 6:00 a.m. to 9:00 a.m. and from 2:00 p.m. to 5:00 p.m., Monday through Friday, **or as otherwise posted**.

Section 2: The SCHEDULE VII title and Table VII-A within Section 397.110 of Chapter 397 - Traffic Schedules of the Municipal Code regarding School Zones shall be amended as follows.

SCHEDULE VII. SCHOOL SPEED LIMITS AND CROSSINGS

Section 397.110. - Table VII-A, School Speed Limits.

The **school** speed limit shall be twenty (20) miles per hour from 6:00 a.m. to 9:00 a.m. and from 2:00 p.m. to 5:00 p.m., Monday through Friday, **or as otherwise posted upon the following streets:**

Blumhoff Avenue from West Maple Street to Wood Hollow Drive
Carr Street from West Academy Drive to Park Lane
Church Street from Wagner Street to West Fourth Street
Golden Gate Parkway 500 feet north and 300 feet south of the School Midblock Crosswalk
Mexico Road from Fox Creek Drive to 1,400 feet west of Westwind Park Drive
Peine Road from 270 feet north of Lick Creek Drive to 190 feet north of Somerset Manor Drive
Schroeder Creek Blvd. from West Pearce Blvd. to 550 feet south of William Dierberg Drive


West Academy Avenue from Blumhoff Avenue to Carr Street

West Northview Avenue from Northview Park Court to Blumhoff Avenue

Section 3: It is hereby declared to be the intention of the Board of Aldermen that the sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are severable, and if any section, paragraph, sentence, clause, phrase or word(s) of this Ordinance shall be declared unconstitutional or otherwise invalid, such unconstitutionality or invalidity shall not affect any of the remaining sections, paragraphs, sentences, clauses, phrases and words of this ordinance since the same would have been enacted by the Board of Aldermen without incorporation in the Ordinance of any such unconstitutional or invalid portion of this Ordinance.

Section 4: This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approval by the Mayor.
