#### **ORDINANCE NO. 545**

### THE CITY OF NORTH MUSKEGON ORDAINS:

The City of North Muskegon Code of Ordinances, Chapter 6 is amended as follows:

1. Section 6-106 is amended to read the following:

Section 6-106. Impoundment

- (a) Impoundment shall occur, where authorized by this chapter, at the county animal shelter or at an animal control shelter or other designated contracted facility registered under Public Act No. 2879 of 1969 (MCL 287.331 et seq.) to provide services to include impounding of animals delivered to the shelter by authority of the city of the county. A contract with an animal control shelter may include shelters in addition to the county animal shelter for services, impoundment, confinement or other functions which the county elects not to perform or is unable to perform. The services and functions of the animal control shelter are governed by state law and county ordinance, if any.
- (b) Any animal control shelter in which an animal is impounded shall carry on release, treatment, adoption or disposal of animals in accordance with the requirements of state law. No dog or cat shall be released for adoption to any person without being neutered. If the animal is too young to neuter at the time of adoption, the fee shall be paid for services, which shall be performed at a later date.
- (c) The city may capture and seize feral or nuisance cat found running at large, or upon any public street, alley, or any public place, or on private property if the cat is not owned by said property owner. The city shall return stray cats with collars or microchipped that include appropriate address information to the property owner and may otherwise surrender the cat to an appropriate shelter.
