

**ORDINANCE NUMBER: 2686**

**AN ORDINANCE OF THE CITY OF SOUTH BELOIT, ILLINOIS AMENDING THE FINE SCHEDULE TO INCLUDE A FINE FOR VIOLATION OF PRIVATE FIRE LANE PARKING ORDINANCES**

WHEREAS, the City of South Beloit, Illinois ("City") has adopted a City Code of Ordinances ("Code"); and

WHEREAS, the City has enumerated fines for violations of various City ordinances in the fine schedule; and

WHEREAS, the City desires to amend the fine schedule to adopt a fine for violations of private fire lane parking ordinances; and

WHEREAS, the City has determined it is in the best interest of the City and its citizens to adopt the amended fine schedule attached hereto as Exhibit A.

NOW THEREFORE, be it ordained by the Mayor and City Council of the City of South Beloit, Illinois as follows:

1. The above recitals are incorporated herein and made a part hereof.
2. The City hereby adopts the fine schedule attached hereto as Exhibit A.
3. Except as amended in this Ordinance, all other provisions and terms of City Code of Ordinances shall remain in full force and effect as previously enacted except that those ordinances, or parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.
4. The Ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.
