

**ORDINANCE NO. 2022-33**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF VENICE, FLORIDA, CHAPTER 2, ADMINISTRATION, ARTICLE VIII, BOARDS, SECTION 2-383, PUBLIC ART ADVISORY BOARD, MODIFYING THE MEMBERSHIP COMPOSITION; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, City Council desires to amend the Code of Ordinances by modifying the membership composition of the public art advisory board.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA**, as follows:

**SECTION 1.** The Whereas clauses above are ratified and confirmed as true and correct.

**SECTION 2.** Chapter 2, Administration, Article VIII, Boards, Section 2-383, Public art advisory board, is hereby amended to read as follows:

**Sec. 2-383. Public art advisory board.**

- (a) *Established; regular members.* There is hereby established a public arts advisory board which shall be composed of six members. One member shall be an employee of the Venice Art Center and one member shall be a Venice Area high school student recommended by the principal or designee. All other members shall be ~~five city residents or the owners of real property located within the city and one member from a Venice area high school student body recommended by the principal or his designee, appointed by the mayor and confirmed by city council.~~ Members shall have appropriate backgrounds in public art, architecture, cultural policy or related fields and should demonstrate an interest and knowledge in public art issues.

- (b) through (h) No change.

**SECTION 3.** All ordinances or parts of ordinances in conflict herewith shall be and the same are hereby repealed.

**SECTION 4.** If any part, section, subsection, or other portion of this ordinance or any application thereof to any person or circumstance is declared void, unconstitutional, or invalid for any reason, such part, section, subsection, or other portion, or the prescribed application thereof, shall be severable, and the remaining provisions of this ordinance, and all applications thereof not having been declared void, unconstitutional, or invalid, shall remain in full force and effect. The city council specifically declares that no invalid or prescribed provision or application was an inducement to

the enactment of this ordinance, and that it would have enacted this ordinance regardless of the invalid or prescribed provision or application.


**SECTION 5.** This ordinance shall take effect immediately upon its approval and adoption, as provided by law.






