ORDINANCE NO. 5802

AN ORDINANCE AFFIRMING SECTIONS 22-92 LEVIED AND 22-94 NO AUTOMATIC ADJUSTMENTS OF THE CODE OF ORDINANCES OF THE CITY OF WARRENSBURG, MISSOURI UPON RECEIPT OF NOTICE UNDER SECTION 393.275 RSMO. UTILITY RATE INCREASE IN THE MATTER OF MISSOURI AMERICAN WATER COMPANY, MISSOURI PUBLIC SERVICE COMMISSION, FILE NO. WR-2022-0303

WHEREAS, the City adopted Ordinance 1512 on July 22, 1968 setting a six percent business license tax on gross receipts as referenced in Section 22-92 Levied of the Code of Ordinances; and

WHEREAS, the City adopted Ordinance 4819 on March 25, 2013, as Section 22-94, No Automatic Adjustments pursuant to Section 393.275 RSMO., and any other applicable authority, that the City shall maintain the tax rate on the gross receipts of utilities without reduction notwithstanding any periodic fluctuations in the tariffs of such utility corporations or any notice thereof; and

WHEREAS, on May 11, 2023, the Missouri Public Service Commission issued notice to the City pursuant to Section 393.275(1) RSMO. of its approved increase of Missouri American Water Company's annual revenues from its provision of water and sewer service by more than seven percent on May 3, 2023, In the Matter of Missouri American Water Company's Request for Authority to Implement General Rate Increase for Water and Sewer Service Provided in Missouri Service Areas, File No. WR-2022-0303; and

WHEREAS, Section 393.275(2) allows a city to maintain the tax rate without reduction of its business license tax on the gross receipts of utility corporations if an ordinance to maintain the tax rate is enacted.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WARRENSBURG, MISSOURI, AS FOLLOWS:

Section 1. That Ordinance 1512 adopted July 22, 1968, as referenced in Section 22-92 Levied of the Code of Ordinances of the City of Warrensburg, Missouri setting a six percent business license tax on gross receipts is hereby affirmed and remains in full force.

Section 2. That Ordinance 4819 adopted March 25, 2013 as Section 22-94 No Automatic Adjustments of the Code of Ordinances of the City of Warrensburg, Missouri is hereby affirmed pursuant to Section 393.275 RSMO, and any and all other applicable authority, the City shall maintain the tax rate on the gross receipts of utilities without reduction notwithstanding any periodic fluctuations in the tariffs of such utility corporations or any notice thereof including, but not limited to, notice sent under Section 393.275 RSMO.


Section 3. This ordinance shall be in full force and effect from and after its passage.

**ORDER TO PROVIDE NOTICE REQUIRED BY
SECTION 393.275.1 TO CITIES OF RATE INCREASE**

Issue Date: May 11, 2023

Effective Date: May 11, 2023

Pursuant to Section 393.275.1, RSMo 2016, the Commission must notify the governing body of each city or county imposing a business license tax on gross receipts of any approved rate increase that exceeds seven percent. The statute requires the Commission to include with such notice to any city or county the percentage increase approved for the utility, together with an estimate of the annual increase in gross receipts resulting from the tariff increase on customers residing in that city or county. Section 393.275.2 then requires the taxing authority to reduce its tax rate to reduce the amount of revenue collected under the tax. The statute does not give the Commission authority

to review the actions taken by the taxing authority, nor does it require the taxing authority to inform the Commission of those actions.

Missouri-American Water Company (MAWC) submitted a response identifying the governing bodies that should receive notice. The information provided by MAWC, including MAWC's revenue increase estimates, is attached to this notice.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall mail a copy of this order and MAWC's May 10, 2023 Response to Order Directing Filing to each city or county identified by MAWC.
2. This order shall be effective when issued.

MAWC RESPONSE TO ORDER DIRECTING FILING



1. On May 3, 2023, the Commission issued herein its *Report and Order*. Among other things, the *Report and Order* directed that MAWC "file the information required by Section 393.275.1, RSMo 2000, and Commission Rule 20 CSR 4240-10.060 no later than May 10, 2023."

2. In response, attached as **Appendix A** is a list of those communities where there is a tariff change designed to increase revenues by greater than 7%. Please note that the estimated change in gross receipts tax assumes no change in number of meters or usage levels from the test year. Thus, the actual change may be greater or lesser than this estimate.

WHEREFORE, MAWC respectfully submits this information in response to the Commission's *Report and Order*.



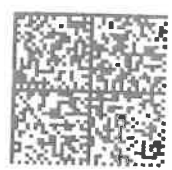
