On motion of Mrs. Noll, which carried 4:0, the following ordinance was adopted:

AN ORDINANCE PURSUANT TO SECTION 46.2-1233.2 OF THE CODE OF VIRGINIA, 1950, AS AMENDED, TO CREATE A TOWING ADVISORY BOARD COMPRISED OF REPRESENTATIVES OF THE YORK-POQUOSON SHERIFF'S OFFICE, OF THE TOWING AND RECOVERY INDUSTRY AND OF THE CITIZENS OF YORK COUNTY, TO REVIEW AND CONSIDER TOWING REGULATIONS AND ADVISING THE BOARD OF SUPERVISORS WITH REGARD TO APPROPRIATE PROVISIONS OF ANY ORDINANCE PERTAINING TO TOWING AND RECOVERY.

WHEREAS, Virginia Code § 46.2-1313 allows a locality to incorporate provisions of the motor vehicle code contained within Title 46 of the Virginia Code, and York County Code § 15-6 adopts state law generally; and

WHEREAS, Virginia Code § 46.2-1233.2 authorizes the creation of a Towing Advisory Board.

NOW, THEREFORE, BE IT ORDAINED by the York County Board of Supervisors this 19th day of March, 2024, that the following be created and enacted as Chapter 15, Article V of the Code of Ordinances of York County, Virginia, "TOWING" which Chapter will read as follows:

Chapter 15. – MOTOR VEHICLES AND TRAFFIC

Article V. TOWING

Sec. 15-70. – Legal Authority

This ordinance is adopted pursuant to the authority of Virginia Code §§ 46.2-1313 and 46.2-1233.2, 1950, as amended.

Sec. 15-71. – Towing Advisory Board

- (a) A Towing Advisory Board is hereby created to review and consider towing regulations and advise the Board of Supervisors regarding appropriate provisions of any ordinance pertaining to towing and recovery of vehicles.
- (b) The Board of Supervisors shall appoint the Towing Advisory Board and shall be comprised of two representatives of the York-Poquoson Sheriff's Office, two representatives of the towing and recovery industry, and one representative of the citizens of York County.
- (c) One of the initial representatives of the York-Poquoson Sheriff's Office shall be appointed for a one-year term commencing May 1, 2024, and ending April 30, 2025. The second of the initial representatives of the York-Poquoson Sheriff's Office shall be appointed for a two-year term commencing May 1, 2024, and ending April 30, 2026. Each subsequent York-Poquoson Sheriff's Office representative shall be appointed for a two-year term.
- (d) One of the initial representatives of the towing and recovery industry shall be appointed for a one-year term commencing May 1, 2024 and ending April 30, 2025. The second of the initial representatives of the towing and recovery industry shall be appointed for a two-year term commencing May 1, 2024, and ending April 30, 2026. Each subsequent representative of the towing and recovery term shall be appointed for a two-year term.
- (e) The initial citizen representative shall be appointed for a one-year term commencing May 1, 2024, and ending April 30, 2025. Each subsequent citizen representative shall be appointed for a two-year term.
