ORDINANCE NO. 12-11-23a

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF JASPER, TEXAS AMENDING/UPDATING CHAPTER 6 SECTIONS 6-11 INSPECTIONS AND 6-19 PERMIT FEES AS REQUIRED BY H.B. 852 EFFECTIVE MAY 21, 2019, PROHIBITS CITIES FROM CALCULATIN RESIDENTIAL BUILDING PERMIT FEES ON THE COST OF A PROPOSED RESIDENTIAL STRUCTURE OR IMPROVEMENT. THIS UPDATE IS FULLY OUTLINED IN THE CITY'S OFFICIAL ORDINANCE BOOK, VOLUME 2017, PAGE 124, RECORDED AS ORDINANCE NO. 61719 AND IS IN NEED OF AMENDING/UPDATING AS REQUIRED BY NEW STATE LEGISLATURE.

WHEREAS, the Jasper, Texas Code of Ordinances Chapter 6 Building and Building Regulations, Chapter 6 Section 11 Inspections and Chapter 6-19 Permit Fees are required to be updated and readopted as per new state legislature H.B. 1922 effective January 1, 2024; and

WHEREAS, the city council has determined that such an update is mandatory and in the best interest of the citizens of Jasper Texas.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JASPER, TEXAS:

PART 1: Section 6-11 Inspections and Section 6-19 Permit Fees shall be updated without changes and readopted in their entirety.

PART 2: City Code of Ordinance Chapter 6-11 Inspections and Section 6-19 Permit Fees shall state as follows:

Chapter 6 Section 6-11 Inspections Fees.

- (a) The building official or designee will do all inspections as required in this code for the fee or fees that are paid for the required permits.
- (b) A re-inspection fee will be assessed when additional inspections are required due to:
 - (1) Faulty material, equipment, apparatus or workmanship; or
 - (2) Failure to cancel inspection request in advance; or
 - (3) Failure to provide inspectors access at scheduled time for inspection.
- (c) Re-inspection fees are charged at a progressive rate as follows:
 - (1) First re-inspection \$45.00
 - (2) Subsequent inspections will be based on the amount of last inspection plus \$45.00.

Chapter 6 Section 6-19 Permit Fees.

Permit and Inspection fees shall apply as stated herein and approved by the city council.
