

**ORDINANCE NO. 12-11-23b**  
**Construction and life safety codes**

**AS PER ORDINANCE NO. 111615 CHAPTER 6 BUILDING AND BUILDING REGULATIONS SECTION 6-12 BUILDING CODE OF THE CITY OF JASPER CODES OF ORDINANCES THE FOLLOWING CONSTRUCTION AND LIFE SAFETY CODES BY THE INTERNATIONAL CODE COUNCIL ARE BEING PRESENTED TO THE CITY OF JASPER CITY COUNCIL FOR ADOPTION BY ORDINANCE. THESE CODES WILL REPLACE THE CURRENT 2015 INTERNATIONAL CODES CURRENTLY IN USE.**

**WHEREAS**, the Jasper, Texas Code of Ordinances Chapter 6 Building and Building Regulations, Chapter 6 Section 6-12 Building Code are required to be updated and readopted as per required guidelines and new state legislature H.B. 1922 effective January 1, 2024; and

**WHEREAS**, the city council has determined that such an update is mandatory and in the best interest of the citizens of Jasper Texas.

**NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JASPER, TEXAS:**

**PART 1:** Chapter 6 Building and Building Regulations Section 6-12 Building Code shall be updated and readopted in their entirety.

**PART 2:** City Code of Ordinance Chapter 6 Building and Building Regulations Section 6-12 Building Code shall state as follows:



4. 2018 INTERNATIONAL MECHANICAL CODE – COMMERCIAL A/C HEATING AND VENTILATION CODE
5. 2018 INTERNATIONAL FUEL GAS CODE – COMMERCIAL NATURAL GAS AND PROPANE SYSTEMS
6. 2018 INTERNATIONAL FIRE CODE – COMMERCIAL FIRE SAFETY CODE
7. 2018 INTERNATIONAL EXISTING BUILDING CODE – CONCERNS CONSTRUCTION AND REMODELING OF EXISTING BUILDINGS
8. 2018 INTERNATIONAL ENERGY CONSERVATION CODE – RESIDENTIAL AND COMMERCIAL ENERGY CONSERVATION FOR NEW CONSTRUCTION AND EXISTING BUILDINGS

**VALIDITY**




