

ORDINANCE NO. 8110

AN ORDINANCE OF THE CITY COUNCIL OF AMARILLO, TEXAS REPEALING ARTICLE V, CHAPTER 2-6: BOARDS AND COMMISSIONS, OF THE AMARILLO MUNICIPAL CODE IN ORDER TO SUNSET THE TRAFFIC ADVISORY BOARD AND THE PEDESTRIAN BICYCLE SAFETY ADVISORY BOARD; PROVIDING REPEALER CLAUSE; PROVIDING FOR SEVERABILITY CLAUSE; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Traffic Commission was established under Ordinance No. 1989 and later amended to the Traffic Advisory Board under Ordinance No. 7897; and,

WHEREAS, the Pedestrian and Bicycle Safety Committee was established under Resolution No. 07-12-16-2; and,

WHEREAS, both the Traffic Advisory Committee and Pedestrian and Bicycle Safety Committee have fulfilled the duties and objectives placed before them; and,

WHEREAS, the City of Amarillo finds it in the best interest of the citizens of the City of Amarillo that the Traffic Advisory Commission and Pedestrian and Bicycle Safety Commissions be sunset.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AMARILLO, TEXAS:

SECTION 1. Chapter 2-6, Boards and Commissions, Article V, Sections 2-6-50 through 2-6-52 are hereby repealed and Sections 2-6-50 through 2-6-55 shall be held in Reserve.

SECTION 2. The Pedestrian and Bicycle Safety Committee shall hereby cease to exist as of the effective date of this Ordinance.

SECTION 3. All ordinances and resolutions or parts thereof that conflict with this ordinance are hereby repealed, to the extent of such conflict.

SECTION 4. In the event this ordinance or any part hereof is found to be invalid, such invalidity shall not affect the remaining portions of the ordinance, and such remaining portions shall continue to be in full force and effect if they can be given effect without the invalid portion.

SECTION 5. This Ordinance shall be effective as of the date of its passage.


