NOTWITHSTANDING ANY PROVISIONS IN THESE REGULATIONS TO THE 2 CONTRARY, DRIVE-THROUGH FACILITIES FOR COMMERCIAL ESTABLISHMENTS EXCEPT BANKS, INCLUDING THE RE-PURPOSING OF EXISTING DRIVE-THROUGH 3 FACILITIES FOR COMMERCIAL ESTABLISHMENTS, ARE PROHIBITED IN THE 4 5 SOUTH TOWSON (SOTO) DESIGN REVIEW AREA. 6 7 SECTION 3. AND BE IT FURTHER ENACTED, that the map dated July 23, 2020 8 known as the "South Towson (SOTO) Design Review Area" attached hereto as Exhibit "A" is 9 hereby adopted by the County Council and shall be added as a Design Review Panel Area to the Comprehensive Manual of Development Policies. 10 11 12 SECTION 4. AND BE IT FURTHER ENACTED, that this Act, having been passed by the affirmative vote of five members of the County Council, shall take effect on August 17, 13
