

ORDINANCE NO. 2008-3948

**AN ORDINANCE OF THE CITY OF ARANSAS PASS
REPEALING 29-28 "WATER RATES" AND SECTION 29-
30(1)(c) *Commercial* and (2), "SEWER RATES" DEALING
WITH THE SAME SUBJECT MATTER TO ADJUST SAID
RATES AND CHARGES; AND PROVIDING FOR AN
EFFECTIVE DATE, AND SEVERANCE.**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ARANSAS PASS,
TEXAS:

Section 1: Section 29-28 "Water Rates", Section 29-30(1)(c) *Commercial* and (2), "Sewer Rates"; of Chapter 29 "Utilities" of the Code of Ordinances of the City of Aransas Pass, Texas which sections apply to certain water and sewer rates and charges are hereby repealed in their entirety.

Section 2: New Section 29-28 "Water Rates", Section 29-30(1)(c) *Commercial* and (2), "Sewer Rates"; of Chapter 29 "Utilities" of the Code of Ordinances of the City of Aransas Pass, Texas are hereby enacted, such sections to read as follows:

Sec. 29-28. Water Rates.

All Property upon which any building or other structure has been or may hereafter be erected, having a connection with any mains or pipes which may be hereafter constructed and used in connection with the city water system shall pay the following rates per month:

Persons sixty-five (65) or older who have duly registered with the city utility department by showing proof of age and residence shall pay the following rates per month.

(c) Commercial

Commercial Customers generating domestic waste with more than one interior residential unit or centralized water meter. Also customers with more than one interior bedroom unit for the accommodation of traveler and other non-permanent residents and customers generating other than normal domestic waste shall pay the following rates per person.

- (1) Those users who have City water and Sanitary sewer facilities made available to them but have disconnected from the City Water System while continuing to utilize the sanitary sewer system shall pay the following monthly flat fee for sewer service:

Residential \$27.50 per month.

Section 3. Severance. If any part of this Ordinance is invalid or void or is declared to be so, then said part shall be severed from the balance of this Ordinance and said invalidity shall not affect the balance of this Ordinance, the balance of the Ordinance to be read as if said invalid or void portion thereof were not included.

Section 4: That this ordinance shall be and become effective immediately upon its passage and approval.
