

ORDINANCE NO. 23-18

AN ORDINANCE IN AMENDMENT OF SECTION 9-4 OF THE CODE OF ORDINANCES, TOWN OF NORTH KINGSTOWN, ENTITLED, "FEE SCHEDULE ENUMERATED - TABLE VI - RECREATION DEPARTMENT FEES - GOLF COURSE"

The Town Council of the Town of North Kingstown hereby ordains:

SECTION 1. That Section 9-4 of the Code of Ordinances, Town of North Kingstown, entitled, "Fee Schedule Enumerated - Table VI - Recreation Department Fees - Golf Course" is hereby amended to read as follows:

SECTION 2. *Definition of resident.* The term “resident”, as referred to in this section, shall mean any person:

1. Who has an established residence in town.
2. Leasing or renting real estate in town.
3. Owning property and currently paying local taxes in town.

SECTION 3. This Ordinance shall take effect on January 1, 2024 and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.
