AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF BASTROP, LOUISIANA ("CITY") TO AMEND AND RESTATE SECTION 20-6 (a)(2) OF THE CODE OF ORDINANCES OF THE CITY OF BASTROP, LOUISIANA, RELATIVE TO THE INSURANCE POLICY LIABILITY LIMITS REQUIRED PRIOR TO THE ISSUANCE OF A PERMIT FOR OWNERS OR OPERATORS OF VEHICLES FOR HIRE, AND ADDRESSING OTHER RELATED MATTERS WITH RESPECT THERETO.

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF BASTROP, LOUISIANA ("CITY") TO AMEND AND RESTATE SECTION 20-6 (a)(2) OF THE CODE OF ORDINANCES OF THE CITY OF BASTROP, LOUISIANA, RELATIVE TO THE INSURANCE POLICY LIABILITY LIMITS REQUIRED PRIOR TO THE ISSUANCE OF A PERMIT FOR OWNERS OR OPERATORS OF VEHICLES FOR HIRE, AND ADDRESSING OTHER RELATED MATTERS WITH RESPECT THERETO.

WHEREAS, Code of Ordinance Section 20-6 (a)(2) of the Code of Ordinances of the City of Bastrop, Louisiana ("City) establishes the insurance policy liability limits required prior to the issuance of a permit for owners or operators of vehicles for hire; and

WHEREAS, the Mayor and Board of Aldermen of the City desire to amend and restate Section 20-6 (a)(2) of the Code of Ordinances to increase the minimum insurance policy liability limits for each accident causing bodily injury and property damage as mandated by LSA-R.S. 32:900 for owners and operators of vehicles for hire.

BE IT THEREFORE ORDAINED that the Mayor and Board of Aldermen of the City of Bastrop by vote approve the increase to the minimum liability limits for each accident causing bodily injury and property damage as mandated by LSA-R.S. 32:900 for owners and operators of vehicles for hire, by amending and restating Section 20-6(a)(2) of the Code of Ordinances to read as follows:

Sec. 20-6. Insurance.

- (2) **The insurance policy shall provide not less than the following limits of liability: for each accident causing bodily injury (including death at any time resulting therefrom) fifteen thousand dollars (\$15,000.00) for each person, thirty thousand dollars (\$30,000.00) for each accident, and twenty-five thousand dollars (\$25,000.00) for property damages sustained in any one (1) accident.**

BE IT FINALLY ORDAINED that all sections of any previous Ordinances enacted,

and sections of the Code of Ordinances enacted, that are in conflict herewith are hereby repealed.
