

ORDINANCE NO. 2754

AN ORDINANCE OF THE COMMON COUNCIL OF THE TOWN OF GILBERT, ARIZONA, AMENDING THE CODE OF GILBERT, ARIZONA, CHAPTER 62 TRAFFIC AND VEHICLES, ARTICLE I IN GENERAL, BY AMENDING SECTION 62-2 SPEED REGULATIONS RELATED TO SPEED LIMITS APPLICABLE TO PUBLIC STREETS IN THE TOWN; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR CIVIL SANCTIONS.

NOW THEREFORE, BE IT ORDAINED by the Common Council of the Town of Gilbert, Arizona, as follows:

Section I. In General.

The Code of Gilbert, Arizona, Chapter 62 Traffic and Vehicles, Article I In General, Section 62-2 Speed Regulations, is hereby amended to read as follows (additions in ALL CAPS; deletions in ~~strikeout~~):

Sec. 62-2. Speed Regulations.

Unless posted otherwise, the following speed limits shall apply to all public streets in the town:

45 MPH, except as set forth below in this section for school areas:

Recker Road: From Pecos Road to Baseline Road EXCEPT AS SET FORTH BELOW IN THIS SECTION.

Williams Field Road: All of Williams Field Road within the town limits EXCEPT AS SET FORTH BELOW IN THIS SECTION.

Gilbert Road: From Hackamore Avenue to ~~Horseshoe Avenue~~ PALO VERDE STREET.

* * *

RECKER ROAD: SOMERTON BOULEVARD TO A POINT 820 FEET NORTH OF SOMERTON BOULEVARD (UNDEVELOPED ACCESS).

RECKER ROAD: FROM COOLEY LOOP ROAD TO VEST AVENUE.

WILLIAMS FIELD ROAD: FROM A POINT 860 FEET WEST OF VERDE DRIVE (UNDEVELOPED ACCESS) TO VERDE DRIVE.

WILLIAMS FIELD ROAD: FROM SOMERTON BOULEVARD TO A POINT 710 FEET EAST OF SOMERTON BOULEVARD (UNDEVELOPED ACCESS).

25 MPH

Gilbert Road: From ~~Horseshoe Avenue~~ PALO VERDE STREET to the Western Canal.

WILLIAMS FIELD ROAD: FROM VERDE DRIVE TO SOMERTON BOULEVARD.

RECKER ROAD: FROM A POINT 820 FEET NORTH OF SOMERTON BOULEVARD (UNDEVELOPED ACCESS) TO COOLEY LOOP ROAD.

Section II. Providing for Repeal of Conflicting Ordinances.

All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the Code adopted herein by reference, are hereby repealed.

Section III. Providing for Severability.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of the Code adopted herein by reference, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

Section IV. Providing for Civil Sanctions.

Any person found responsible for violating this section shall be subject to the civil sanctions and habitual offender provisions set forth in Section 1-5 of the Gilbert Municipal Code.


