

ORDINANCE NO. 2930

AN ORDINANCE OF THE COMMON COUNCIL OF THE TOWN OF GILBERT, ARIZONA, AMENDING THE CODE OF GILBERT, ARIZONA, CHAPTER 42 OFFENSES AND ABATEMENT OF PUBLIC NUISANCES, ARTICLE III OFFENSES INVOLVING PUBLIC PEACE AND ORDER, DIVISION 1 GENERALLY, SECTION 42-62 SPECIAL NOISE SOURCES; AND PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES.

BE IT ORDAINED by the Common Council of the Town of Gilbert, Arizona, as follows:

Section I. In General.

The Code of Gilbert, Arizona, CHAPTER 42 OFFENSES AND ABATEMENT OF PUBLIC NUISANCES, ARTICLE III OFFENSES INVOLVING PUBLIC PEACE AND ORDER, DIVISION 1 GENERALLY, SECTION 42-62 SPECIAL NOISE SOURCES; is hereby amended to read as follows (additions in ALL CAPS and UNDERLINE; deletions in ~~strikeout~~):

Sec. 42-62. Special noise sources.

(b) *Sound trucks; loudspeakers; other sound amplifiers.* It is unlawful to play, operate, or use any device known as a sound truck, loudspeaker ~~or sound amplifier~~, radio or phonograph with a loudspeaker, ~~or sound amplifier~~ (INCLUDING ANY MECHANICAL OR ELECTRICAL MUSICAL INSTRUMENT OR MUSIC PRODUCING DEVICE EQUIPPED WITH AN ELECTRICAL AMPLIFIER OR LOUDSPEAKER), or any instrument of any kind or character which emits ~~loud and raucous~~ UNREASONABLE noises WHICH ORIGINATE FROM PUBLIC AREAS WITHIN GILBERT, ~~and is attached to and upon any vehicle~~ unless such person ~~in charge of such vehicle shall have~~ HAS first applied to and received a permit from the chief of police ~~to operate any such vehicle so equipped~~ FOR SUCH ACTIVITY, AND PROVIDES SAID PERMIT, ON REQUEST, TO ANY EMPLOYEE OF THE TOWN OF GILBERT. Such permit ~~shall~~ MAY be granted, ~~unless~~ SO LONG AS the chief of police believes the activity will NOT disturb the public peace. NOTHING IN THIS SECTION SHALL BE CONSTRUED AS TO PROHIBIT NOISES PRODUCED BY LOCAL, COUNTY, STATE, OR FEDERAL EMPLOYEES, OR THEIR VEHICLES, WHILE IN THE COURSE OF THEIR OFFICIAL DUTIES.

Section II. Providing for Repeal of Conflicting Ordinances.


All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the Code adopted herein by reference are hereby repealed.




