

AN ORDINANCE

THE MAYOR AND BOARD OF ALDERMEN DO HEREBY ORDAIN THAT CHAPTER 90 TRAFFIC AND VEHICLES, OF THE CITY OF ACWORTH, GEORGIA, CODE OF ORDINANCES IS HEREBY AMENDED AS FOLLOWS:

Section 1:

Amending Chapter 90 Traffic and Vehicles – Article II Operation of Vehicles, Section 90-48 of the City of Acworth, Georgia, Code of Ordinances by adding subsection 90-48(i) as follows:

Article II Operation of Vehicles

Sec. 90-48. - Designated streets as “no parking” during certain hours.

(a) Clubhouse Court, Clubhouse Drive, Cool Springs Court, Cool Springs Drive, Cool Springs Place, Five Iron Court, Four Iron Place, Six Iron Court, Spring Ridge Court, Spring Ridge Drive, Tennis Court Lane, Two Iron Trail, and Two Iron Way, streets within the Blue Springs Subdivision shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

(b) Baker Grove Road from the Tanyard Creek Bridge to Hickory Grove Road, Grove Park Terrace, Grove Park Way, Orange Drive, Grove Drive, Grove Court, Grove Trail, Peach Terrace, Peach Court, Orange Court, Zephyrhills Drive, Yukon Trail, Quincetree Way, Everglades Court, Coconut Grove, Peartree Drive, Mangrove Terrace, streets within the Grove Park Subdivision shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

(c) Huddlestone Bridge Pkwy, Whitmore Ct., Reservoir Pass, Walforde Blvd., Kentland Dr., Delacourte Dr., Columbus Cir., Gapstow Bridge Ln., and Balto Way, within the Huddlestone Bridge Subdivision shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

(d) Lake Park Lane, Lake Park Circle, Noah Way, Noah Court, Lake Park Terrace, Noah Trace, Noah Ridge, Bridgewalk Trail, Noah Drive, Noah Overlook East, Noah Overlook West, Lake Park Drive, Lake Park Bend, Lake Park Ridge East, Lake Park Ridge West, Lake Park Court, Lake Park Trail, Lake Park Place, Noah Circle, Noah Lane, and Noah Valley, within the Lake Park Subdivision shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

(e) Creekside Village Drive, Butler Springs Trace, Chapel Road, Quickwater Landing, Palm Circle, Indigo Creek Trail, Northfield Way, Juniper Drive, all streets within the Creekside Village Subdivision shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

(f) Creel Chase, Creel Court, Darter Drive, Darter Cove, Darter Way, Bass Way, Bass Chase, Bass Pointe, Darter Run, Darter Point, and Xavier Drive, all streets within the **Brookhaven Subdivision** shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

(g) Park Forest Drive, Park Forest Way, and Park Forest Court, all streets within the **Park at Brookhaven Subdivision** shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

(h) Baker Plantation Drive, Baker Plantation Way, Baker Plantation Ridge, Cooks Court, Pastry Lane, Souffle Court, Julian Way, and Parfait Place and all streets within the Baker Plantation Subdivision shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

(i) Mitchell Hill Drive, Hill View Drive, Overlook Drive, Ridgecrest Court, Kildare Court and Wexford Downs Way shall be designated as no parking from 12:00 a.m. until 6:00 a.m.

Section 2: It is hereby declared to be the intention of this Ordinance that its sections, paragraphs, sentences, clauses and phrases are severable, and if any section, paragraph, sentence, clause or phrase of this Ordinance is declared to be unconstitutional or invalid, it shall not affect any of the remaining sections, paragraphs, sentences, clauses or phrases of this Ordinance.

Section 3: All Ordinances in conflict with this Ordinance are hereby repealed.

Section 4: This Ordinance shall become effective upon passage by the Mayor and Board of Aldermen of the City of Acworth and signature of the Mayor subject to Georgia Laws 1983, page 4119.
