## ORDINANCE NO. 17-01-04

AN ORDINANCE DE-ANNEXING FROM THE CITY LIMITS OF NICEVILLE, FLORIDA, CONTIGUOUS LANDS DESCRIBED AS FORTH HEREIN; PROVIDING FOR PROPER ADVERTISEMENT PURSUANT TO FLORIDA STATUTES 171.044; PROVIDING THAT THE PROPERTY WILL BE DE-ANNEXED AND UNINCORPORATED FROM THE CITY LIMITS OF NICEVILLE, FLORIDA: PROVIDING FOR THE SEVERABILITY OF THIS ORDINANCE; PROVIDING AN EFFECTIVE DATE PROVIDING FOR FILING WITH THE CLERK OF COURT AND DEPARTMENT OF STATE.

WHEREAS, the City Council of the City of Niceville, Florida has been presented with a written request signed by owner of real property requesting that the incorporated property area, currently zoned R-1, Single Family Residential, be de-annexed and unincorporated from the City limits of Niceville, Florida; and

WHEREAS, notice of public hearing concerning said annexation has been duly publicized and said hearing having been held this date and that the Council has considered the objections, if any, made by various citizens.

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF NICEVILLE, FLORIDA:

<u>SECTION 1</u>. The following described incorporated property area, contiguous to and in the City limits of Niceville, Florida, be and is hereby de-annexed and unincorporated from the City:

SECTION 2. That the boundary line of the City of Niceville, Florida shall be redefined to exclude and remove the said property area from the City limits of Niceville, Florida as defined in Section 1 of this Ordinance.

SECTION 3. In order to comply with the provisions of Section 171.044 of the Florida Statutes, a notice of this de-annexation shall be published once each week for two (2) consecutive weeks in a newspaper published in Okaloosa County, Florida, and shall give the Ordinance number and a brief general description of the property area proposed to be de-annexed and unincorporated from the City.

SECTION 4. The property, currently zoned R-1, Single Family Residential, is hereby deannexed and unincorporated from the City limits of Niceville, Florida and the official zoning map is hereby amended to reflect same.

SECTION 5. This Ordinance is declared severable and any provision declared invalid shall not affect the other provisions hereof.

SECTION 6. After its enactment, one copy of said Ordinance shall be filed with the Clerk of Okaloosa County, Florida, and one copy of said Ordinance shall be filed with the Department of State.
