ORDINANCE NO. 17-04-01

AN ORDINANCE FOR THE REZONING OF CERTAIN PROPERTIES IN THE CITY OF NICEVILLE, FLORIDA; PROVIDING ZONING FOR SAME AND; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, application has been made to the City Council by John Tidwell for the rezoning of the property located 204 Ellis Avenue, hereinafter described, from R-1, Single Family Residential to PUD, Planned Unit Development and have a future land use of MU, Mixed Use, and

WHEREAS, notice of public hearing concerning said rezoning has been duly publicized and said hearing having been held this date and that the Council has considered the objections, if any, made by various citizens.

SECTION 1. That the following described, property previously zoned PUD, Planned
Unit Development and have a future land use of MU, Mixed Use:

Less and except that certain property conveyed to J.C. Marler on February 16, 1940 being described as follows:
