7 AN ORDINANCE AMENDING SECTION 154.107 (SALE AND  
8 CONSUMPTION OF ALCOHOLIC BEVERAGES IN MUNICIPAL  
9 PARKS OR ON CITY-OWNED OR -LEASED PROPERTY;  
10 PENALTY), *ORDINANCE CODE*, TO ADD AIRPORTS TO  
11 THE LIST OF LOCATIONS THAT ALLOW ALCOHOLIC  
12 BEVERAGES TO BE SOLD, SERVED AND CONSUMED;  
13 PROVIDING AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Amending Section 154.107 (Sale and consumption**  
17 **of alcoholic beverages in municipal parks or on City-owned or -leased**  
18 **property; penalty), *Ordinance Code*.** Section 154.107 (Sale and  
19 consumption of alcoholic beverages in municipal parks or on City-owned  
20 or -leased property; penalty), *Ordinance Code*, is hereby amended to  
21 read as follows:

23 **CHAPTER 154. ALCOHOLIC BEVERAGES**

24 **PART 1. IN GENERAL**

26 **Sec. 154.107. Sale and consumption of alcoholic beverages in**  
27 **municipal parks, ~~or~~ on City-owned or -leased property, or airports;**  
28 **penalty.**

30 (j) Alcoholic beverages, which have been purchased or served under  
31 the authority of any alcohol license issued to the  
Jacksonville Aviation Authority pursuant to F.S. § 561.17,

1           may be sold, served and consumed at the Jacksonville  
2           International Airport located at 2400 Yankee Clipper Drive  
3           and as otherwise consistent with State of Florida law and  
4           City Municipal Code requirements, including but not limited  
5           to, Section 154.301 pertaining to hours of operation for the  
6           sale, consumption and service of all alcoholic beverages.  
7           Jacksonville Aviation Authority owns and operates Jacksonville  
8           International Airport pursuant to Chapter 2001-319 Laws of  
9           Florida.

10       ~~(j)~~(k) Nothing contained in this Section is intended to encourage,  
11       promote or otherwise sanction or provide a defense for conduct  
12       that is unlawful under federal, State or local law including,  
13       but not limited to, disorderly intoxication, driving under the  
14       influence of alcohol, or possession of illegal substances.

15       ~~(k)~~ (l) Nothing contained in this Section is intended to limit the  
16       lawful discretionary authority of the Jacksonville Sheriff's  
17       Office, the Jacksonville Aviation Authority police or federal or  
18       state law enforcement agencies to enforce or not enforce the  
19       provisions herein as permitted by statute, case law or other  
20       legal enactment.

21       ~~(l)~~ (m) Nothing contained in this Section is intended to affect the  
22       prosecution of selective enforcement claims under the federal or  
23       State constitutions based on race, gender, ethnicity or other  
24       suspect categories as such claims are currently defined under  
25       well-established case law.

26       **Section 2.           Effective Date.** This Ordinance shall become  
27       effective upon signature by the Mayor or upon becoming effective  
28       without the Mayor's signature.
