**ORDINANCE 2002-428-E**

AN ORDINANCE AMENDING SECTION 122.102,  
ORDINANCE CODE, TO DESIGNATE THE NAME  
"JACKSONVILLE VETERANS MEMORIAL ARENA" FOR  
SAID BUILDING; PROVIDING AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

**Section 1.** Section 122.102, Ordinance Code, is hereby  
amended, in part, to read as follows:

**CHAPTER 122**

**PUBLIC PROPERTY**

**PART 1. MUNICIPAL BUILDINGS AND OFFICES**

\* \* \*

**Sec. 122.102 Naming of public facilities regulated.**

(a) No public facility in the city shall be named after any  
living person.

(b) The main library for the City of Jacksonville shall not  
bear the name of any individual but shall be designated "The  
Jacksonville Public Library".

(c) The Duval County Courthouse shall not bear the name of  
any individual but shall be designated "The Duval County  
Courthouse".

(d) The Jacksonville Veterans Memorial Arena shall not bear  
the name of any individual or company or any other thing as any  
part of the title, but shall be designated only as "Jacksonville  
Veterans Memorial Arena".

Section 2. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.


