**AT A MEETING OF THE BOARD OF SUPERVISORS OF THE COUNTY OF GOOCHLAND, VIRGINIA, HELD ON APRIL 18, 2017, IN THE GOOCHLAND COUNTY ADMINISTRATION BUILDING, 1800 SANDY HOOK RD., SUITE 250, GOOCHLAND, VIRGINIA, THE FOLLOWING ACTION WAS TAKEN:**

**An ordinance to amend Chapter 5.5 (Fees and Taxes), Article II (Schedule of Fees and Charges), Section 5.5-17 (Building inspection fees) to decrease the fee for commercial/industrial building permits, to increase the reinspection fee and to increase the per permit renewal fee; Section 5.5-18 (Fees for development) to add fees for rezoning applications to create one additional residential lot and applications for Mixed Planned Unit Development (MPUD); and Section 5.5-31 (Emergency medical services) to increase emergency medical services transport fees of the Goochland County Code of Ordinances**

**WHEREAS**, §§ 15.2-1427 and 15.2-1433 of the Code of Virginia (1950, as amended) enable a local governing body to adopt, amend, and codify ordinances or portions thereof; and

**WHEREAS**, § 15.2-2286 of the Code of Virginia provides for the collection of fees to cover the cost and expense of administration of the zoning ordinance or the filing or processing of any appeal or amendment thereto; and

**WHEREAS**, the Board of Supervisors wishes to decrease the fee for commercial/industrial building permits; to increase the reinspection fee; to increase the per permit renewal fee; to add a fee for rezoning applications to create one additional residential lot; to add a fee for Mixed Planned Unit Development (MPUD) applications; and to increase emergency medical services transport fees; and

**WHEREAS**, the Board of Supervisors wishes to amend and update the County Code for the foregoing reasons; and

**WHEREAS**, this ordinance is required to serve the health, safety, and welfare of the citizens of Goochland County; and

**WHEREAS**, the full text of this proposed ordinance amendment was available for public inspection in the Goochland County Administrator's Office, County Administration Building, 1800 Sandy Hook Road, Goochland, Virginia 23063; and

**WHEREAS**, a public hearing was conducted on Tuesday, April 4, 2017, at 7:00 p.m. at the Goochland County Administration Building, Board Meeting Room 250, 1800 Sandy Hook Road, Goochland, Virginia 23063 after proper advertisement was made, as required by law.

**NOW, THEREFORE, BE IT ORDAINED**, that the Goochland County Code is hereby amended and this ordinance is hereby enacted as follows:
