

**ORDINANCE NO. 1596**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY  
OF FONTANA AMENDING THE CITY OF FONTANA  
MUNICIPAL CODE, CHAPTER 2, ARTICLE IV, SECTION  
2-142 CHANGING THE DATES OF THE REGULAR CITY  
COUNCIL MEETINGS**

**THE CITY COUNCIL OF THE CITY OF FONTANA, CALIFORNIA, DOES  
ORDAIN AS FOLLOWS:**

**Section 1.** Chapter 2, Article IV, Section 2-142 of the Fontana Municipal Code is hereby amended to read in its entirety as follows:

**Section 2-142 City Council**

"The City Council shall hold its regular meeting on the second and fourth Wednesday of each month at 7:00 p.m., or at such other day and time as may be provided by resolution, or for adjourned meetings, order of adjournment."

**Section 2.** This Ordinance shall take effect thirty (30) days after the date of the adoption and prior to the expiration of fifteen (15) days from the passage thereof, shall be published by the City Clerk at least once in the Herald News, a local newspaper of general circulation, published and circulated in the City of Fontana, and henceforth and thereafter the same shall be in full force and effect.




