AMENDING CHAPTER 23 (PARKS AND LEISURE SERVICES SECTION 23-6, OF THE CODE OF ORDINANCES OF THE CITY OF LAREDO TO INCLUDE BASEBALL RENTAL FEES FOR THE UNI-TRADE STADIUM. RENTAL FEES TO INCLUDE THE SITE FEE \$600.00 PER DAY, GAME ADMINISTRATOR FEE \$100.00 PER DAY, POLICE OFFICER FEE \$400.00 PER GAME, SCORE BOARD OPERATOR FEE \$50.00 PER GAME, ANNOUNCER FEE \$50.00 PER GAME, TICKET SALESPERSON FEE \$35.00 PER GAME, TICKET COLLECTOR FEE \$35.00 PER GAME, CLERK FEE \$40.00 PER GAME, CUSTODIAN FEE \$200.00 PER DAY, GROUNDS FEE \$290.00 PER DAY; AND PROVIDING FOR PUBLICATION AND EFFECTIVE DATE (AS AMENDED).

WHEREAS, the City of Laredo is committed to provide the Laredo community young boys and girls opportunities to enjoy organized baseball and softball events; and

WHEREAS, in order to operate the stadium facility and offset the facilities costs the following rental fees are hereby proposed to be implemented for turn-key baseball uses:



NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:


Section 1: The City Manager is authorized to implement turn-key baseball rental fees for the use of the Uni-Trade facility for organized recreational purposes
