**AN ORDINANCE OF THE COUNCIL OF THE TOWN OF SPRINGDALE  
PROHIBITING CANNABIS DISPENSARIES AND SMOKING  
ESTABLISHMENTS**

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Town of Springdale, SC that the Ordinances for the Town of Springdale, Chapter 15 be added as follows:

**Definitions.**

*Cannabis Product.* A Product originating from the species Cannabis Sativa L., excluding marijuana as defined in S.C. Code Ann. Sec 44-53-110(27), and shall include all forms of Cannabis or low-THC Cannabis product (CBD) to be consumed or applied.

*Marijuana.* (i) All species or variety of the marijuana plant and all parts thereof whether growing or not; (ii) the seeds of the marijuana plant; (iii) the resin extracted from any part of the marijuana plant; or (iv) every compound, manufacture, salt, derivative, mixture, or preparation of the marijuana plant, marijuana seeds or marijuana resin.

*Drug and Tobacco Establishment.* Any premises where drug and tobacco paraphernalia is displayed for sale, offered for sale, or sold, and which devotes more than a two-foot (2') by four-foot (4') (two feet (2') in depth maximum) section of shelf space for drug and tobacco paraphernalia.

**Prohibition of Smoking Establishments.**

No establishment may operate whose primary purpose is to sell or offer for sale to consumers, but not for resale, tobacco products and paraphernalia, in which the sale of other products is merely incidental, and in which the entry of persons under the age of 18 is prohibited at all times.

**Prohibition of Cannabis Dispensaries.**

No business may engage in the merchandising or sale of products containing hemp, hemp derived Cannabidiol (CBD), CBD oils, tetrahydrocannabinol (THC), Cannabis, Cannabis Product, or vaping product of alternative consumable matter other than tobacco meant to be smoked, vaped or ingested orally in any fashion.

No business may engage in the merchandising or sale of marijuana for medical purposes.

**Jurisdiction, Enforcement, and Penalties**

- (a) A person who owns, manages, operates, or otherwise controls an establishment or business and who fails to comply with the provisions of this section shall be deemed guilty of an infraction for each occurrence of noncompliance.
- (b) An infraction is punishable by a fine of \$1,000.00. Each occurrence of a violation of this section shall be considered a separate and distinct infraction.

**Severability.** If any section, subsection, or clause of this ordinance shall be deemed to be unconstitutional or otherwise invalid, the validity of the remaining sections, subsections, and clauses shall not be affected thereby.

**Conflicting Ordinances Repealed.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**Effective Date.** This ordinance shall become effective immediately upon second reading.
